Since the County was doing some work in the area, it was easy for them to do the access points to Hwy. 63 and in exchange for that, MDOT pledged to give the County title to sections of Friendship Church Road and Roy Barnes Road.

Quite a bit of time had transpired before MDOT got around to following up on that pledge for the exchange. Due diligence by the County through survey found that the property owner along Friendship Church Road had encroached into the State's right-of-way. The State resolved the issue by deeded that area, by survey and Quitclaim Deed, to that property owner.

We have verified the legal description for the remainder of the property coming to the County. The Commission has signed off on that about one month ago and the Missouri Highway and Transportation Commission has signed off on the Quitclaim Deed and has returned to us for acceptance.
