#### 8. Public comment

Jon Cole said he is a Land Surveyor with Merebrook LLC Land Surveying and is here today to address a previously scheduled first reading on the clarification for the rules and regulations regarding set back property lines. The item has been pulled from the agenda today to be rescheduled as a first reading at a later meeting.

Mr. Cole said he would like the following put into the record for further clarification and consideration:

Please consider the following for a clarification of the existing Boone County Subdivision Regulations. I believe this clarifies and re-states what has been commonly done in the past in this and many other counties.

For the purposes of clarification of the Boone County Subdivision Regulations and the Boone County Zoning Regulations, building setback lines shall be measured as follows:

Minimum lot width at the building line shall meet or exceed the minimum building setback per applicable zoning regulations. It shall be measured at a perpendicular distance from the front of the lot. In the event that this is not desirable or practical, the building setback distance may be increased so as to meet or exceed the minimum lot width at the new setback line.

This allows for the possibility that if the regulation does not work on a particular lot, it can be pushed back further in order to meet the width. This would be a secondary and simpler way to do this.

Commissioner Atwill thanked Mr. Cole for his input and said this will be put into consideration.

Don Bormann said he has read the proposal and knows the intent of the proposal, but when reading, it seems more confusing than what the original language currently says. He believes there are unintended consequences. This will push more properties to the Board of Adjustment for waivers because there are existing pieces that can't conform to this. It is a bad result.

Also, on rural properties, this will make cul-de-sacs larger than originally intended and the County will eventually have to maintain a larger section.

The Commissioners thanked Mr. Bormann for speaking and said this will be taken into consideration.
