7. 1st & 2nd reading; Change Order #1 for the Emergency Communication Center

Commissioner Miller said that Erik Miller from PWA and Joe Gruender from Little Dixie are here to explain to the Commission the issue concerning the Change Order and the amount of the Change Order.

Erik Miller said that the packets the Commissioners have represent the reason for the Change Order, the pricing estimate and a drawing of the areas needing the soil replacement. From time-to-time, on-site locations encounter some extremely poor soil conditions. This has occurred on the north end of the site as well as a few hundred feet to the south where we are

preparing to build a construction access road. The road, while listed as a construction road, will become a permanent road in its final application. In the mean time, it will act as a construction road access and emergency access in the event of an emergency.

The issue was brought forward to us on March 10th when Sapp & Sons were in the process of clearing the area to begin the grading operation to install the road. On several occasions the vehicles got stuck in the mud partly due to the wet conditions that have exacerbated the problem that has existed all along. There is no previous history of testing that would have alerted us to this problem. The soil is highly plastic, it does not hold up well to heavy vehicles. Subsequently, myself, Allstate Consultants, Little Dixie and a member of County staff met at the site to discuss the conditions and the best methodology to fix the problem.

The pricing structure attached is based on the repairs suggested on the drawing by Allstate Consultants. The repairs will be completed by adding several different elements. What will be done, in lieu of trying to excavate all that is bad, is to excavate down to certain levels and reinforce with a product called Geogrid as well as other fabrics.

It should be noted that the structure of the Change Order as written, will be a unit price structure and the Commission will be approving a certain amount of money. The work will go on and the costs will be identified and verified by the contractor and then confirmed by the County representative. It is possible that the final tally will not equal the total listed on the Change Order.

Commissioner Miller said that yesterday, the discussion consisted of using one filter fabric base and two Geogrids. Today, the documentation shows two filter fabric bases and one Geogrid.

Erik Miller said the wrong documentation was added to the packet. It is not correct and should be what was discussed yesterday, the one filter fabric and two Geogrids. The correct

documents will be inserted into the packet for signatures. (Dan Marshall made copies of the correct documentation and they were inserted into the three packets for signatures)

Commissioner Thompson asked if the pricing is correct. There appears to be multiple pricing.

Commissioner Miller said the pricing is correct, the wording is just wrong.

Mr. Gruender said there are two different areas which is the reason for the difference in the pricing. The one area requires two layers of GeoGrid along with the fabric. In essence, it is fabric and rock, Geogrid/rock, Geogrid/rock and actual road. The other area is fabric, bottom rock, Geogrid/rock and road.

Commissioner Thompson said that explanation makes the paperwork more understandable.

Dan Marshall from Resource Management said as long as nothing changes, they approve of the recommendation presented.

There were no further comments or questions.

Commissioner Thompson moved on this day the County Commission of the County of Boone does hereby authorize Commissioner Karen M. Miller to sign the attached Change Order #1 in lieu of Commissioner Atwill's signature regarding the Emergency Communication Center project.
