This amendment changes the name from The Curators of the University of Missouri (on behalf of the University of Missouri Assessment and Consultation Clinic) to The Curators of the University of Missouri (on behalf of the Thompson Center) and clarifies the mission of the Thompson Center.

3. First reading; Sole Source Approval 121-123116SS – Multi-Section Base Station Antennas Term & Supply

Liz Sanders read the following memo:

Attached is a Sole Source Request Form from our Radio Consultant, Dave Dunford, to purchase Multi-Section Base Station Antennas for the new Radio Tower from Alive

Telecommunications of Mokena, Illinois.

According to Dave Dunford, our radio consultant, the radio signal filtering equipment is considered sole source because they are custom built multi-section antennas. This is the only known product that is light weight, omni-directional and provided in a 4-section configuration on a 20' mounting mast. This type antenna is required to meet the technical needs encountered by the requirement for a multi-section antenna within the allowed nominal 20' vertical mounting space.

The equipment will be purchase from department 4101 – ECC Radio & Technology, account 71201 – Construction Costs. Anticipated expenditures from this Term and Supply contract are:

Joint Communications Tower \$3,750

Battle High School Tower \$4,875

Mount Zion Road & Grisum Road \$6,000

9-1-1 phone calls in 2014, an increase of 5,577 calls from 2013.

Therefore, in honor of the men and women whose diligence, professionalism and sense of duty help to keep the citizens of and visitors to Boone County safe, the Boone County Commission recognizes the week of April 12 through April 18, 2015 as National Public Safety Telecommunicators Week. Resource Management

7. First reading; Name an unnamed road as Bentlage Drive

Ryland Rodes said this is a request to name an unnamed County maintained road to Bendlage

Drive. Said road being in Section 13, Township 46 North, Range 12 West as shown as a sixty-six foot wide roadway on surveys recorded in book 4362, pages 181 and 182 of the Boone County Records.

Bentlage Drive will begin on the east side of Hagans Road approximately 2700 feet south of the intersections of Hagans Road and Route Y and running in an easterly direction for approximately 2000 feet, thence turning and running in a southerly direction for approximately 2600 feet.

As noted on the second page, we received 100% of the property owners along the road, sign the petition as well as agree on the name of the road. Usually, we are hoping for at least 66% and in this case got to 100%.

Commissioner Miller asked how it came that the County does maintenance on a road that was not named.

Mr. Rodes said he believes that Hagans Road was actually this road at one time. The west side of Hagans Road was developed and the street sign was switched. Looking at mapquest, the portion of the road we want to rename is actually shown as S. Hagans Road. So, there is some confusion out there. This will be good for the property owners, not only to get the road maintenance, but for other County services, postal services and 911 services.

They have subdivided several lots and there are about nine different tracts, each is 20 acres or more which can accommodate two dwellings on each tract. This has the potential of 18 additional homes. It is nice to know that they will have these services available, especially the emergency services.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the County Clerk to schedule

Family Court Services

8. First reading; Juvenile Justice Program Assistance Grant application

Courtney Pulley said they are requesting to re-apply for the Juvenile Justice Program
Assistance grant. This is used to fund Intensive Crisis Intervention Services, In-Home
Monitoring Services, Shelter Care Services and the Evening Reporting Center Program. This
has also had an impact on our detention numbers. The number in 2012 was 170 and we are
down to 140. This is a positive thing. This has also helped with the Disproportionate
Minority Contact Committee. Our relative rate index has gone from 7.7 to 5.7 which is a
positive trend. These resources are really helpful when dealing with at risk youths who have
been taken into custody by law enforcement or are violating conditions of their supervision.

We are requesting \$24,946 which is slightly higher than last year to maintain these programs. It is totally reimbursable to the County. The Evening Reporting Center has taken on some additional responsibilities and is one of the reasons for the slightly higher request this year.

There were no comments or questions.

Commissioner Atwill stated this is a first reading and requested the County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

9. First reading; Budget Amendment – Transfer excess Tax Maintenance Fund to General Fund

Brian McCollum said this amendment is requested to cover the amount identified in the Excess Tax Maintenance fund to be transferred to the General Revenue fund for the last fiscal year. That amount is \$24,641 and is transferred over per statute 52.317.

Commissioner Miller asked how this amount is determined.

Mr. McCollum said the fund balance is capped at ½ of the prior year's budget for the Collector's Office. Anything over that dollar amount is transferred to the General Revenue fund.
