Proclamation

1. Proclamation recognizing the week of April 19-25, 2015 as National Crime Victims' Rights Week

Commissioner Thompson said she would like to thank everyone in the Prosecutor's Office and those folks who supported the efforts this weekend for the 5K race. The funds for this race were through a grant that Bonnie Adkins was able to get. It was well attended despite the weather. This was a wonderful opportunity to show people how important the work is within the Prosecutor's Office and also how far reaching the impact of crime is upon our community. A crime victimizes not only the individual, but the entire community.

Commissioner Thompson read the following proclamation:

Whereas, three million persons in America experienced at least one violent victimization in 2013, and

11.5 million households experienced one or more property victimizations; and

Whereas, less than half of violent crimes were reported to police in 2013, and less

than one out of ten violent crime victims received assistance from a victim service agency; and

Whereas, victims and survivors of crime across America need and deserve consistent access to support and assistance that can help them cope with the short-and long-term consequences of crime; and

Whereas, National Crime Victims' Rights Week – April 19-25, 2015 – is an important time to join together to engage communities and empower victims in our Nation's efforts to promote individual and public safety and justice; and

Whereas, "Engaging Communities" requires recognition of the devastating impact that crime has on individuals, families, neighborhoods, schools and the economy of our Nation, which calls for a collective response from everyone in America to address crime prevention, justice and victim assistance; and

Whereas, "Empower Victims" requires a collective understanding of the devastating emotional, physical, financial, spiritual and social impact of crime on victims and survivors, and a national commitment to provide support and services to victims that respect their autonomy and privacy and promote their personal safety; and

Whereas, victims and survivors of crime can gain strength from the wide range of supportive services offered by over 10,000 community- and justice system-based programs, and the more than 32,000 Federal and State statutes that define and protect their rights;

Therefore, the Boone County Commission does hereby proclaim the week of April 19-25, 2015, as National Crime Victims' Rights Week, honoring crime victims and those who serve them during this week and throughout the year and encouraging the citizens of Boone County to recognize the significant accomplishments of our

Nation's victim assistance field, and to recommit our collective energies to "engaging communities" and "empowering crime victims and survivors" in America and around the world.
