#### **Proclamation**

#### 1. Proclamation recognizing Boone County, Missouri as a Purple Heart County

Commissioner Atwill said we are privileged to have the Military Order of the Purple Heart here with us today. We are going to present a proclamation to this organization but before we do that, Commander John Dismer would like to speak.

Commander Dismer said the Military Order of the Purple Heart of Missouri would like to thank the county of Boone for its proclamation support. We are an organization comprised entirely of combat wounded veterans who proudly wear the oldest combat decoration still in use. It was originated on August 7, 1782 by George Washington.

The decoration stayed dormant until 1932 when it was re-introduced and re-designed with a George Washington bust on the front. The Purple Heart is awarded to members of the armed forces who were wounded by an instrument of war at the hands of the enemy and posthumously to the next of kin to those who have died in action or died of wounds in action.

Only six tenths of one percent of everyone that has served in the military has received a Purple Heart. It is an award that no one wants to receive and it represents the price we pay for our freedom. With this heartfelt gesture, we have the appreciation of the community in this meaningful way.

Commissioner Atwill thanked Commander Dismer for his comments and read the following proclamation:

Whereas, Boone County, Missouri has a great admiration and the utmost gratitude for all the men and women who have selflessly served their country and this community in the Armed Forces; and

Whereas, veterans have paid the high price of freedom by leaving their families and communities and placing themselves in harm's way for the good of all; and

Whereas, the contributions and sacrifices of the men and women who served in the Armed Forces have been vital in maintaining the freedoms and way of life enjoyed by our citizens; and

Whereas, many men and women in uniform have given their lives while serving in the Armed Forces; and

Whereas, citizens of our country have received the Purple Heart Medal as a result of being wounded while engaged in combat with an enemy force, construed as a singularly meritorious act of essential services; and

Whereas, Boone County, Missouri seeks to remember and recognize veterans who are recipients of the Purple Heart Medal; and

Whereas, the Boone County Commission desires to proclaim Boone County,
Missouri to be a Purple Heart County honoring the service and sacrifices of our
nation's men and women in uniform, wounded or killed by the enemy while serving
to protect our freedoms; and

*Therefore*, the Boone County Commission does hereby support Boone County, Missouri becoming a Purple Heart County.

They receive their funding through the Stop Act Grant, about \$6,000. This provides a positive reward for those places that do not serve to minors and they get a reward for being in compliance.
