The meeting was called to order at 3:01 p.m.

1. Presentation of the Proposed Budget - FY2016

June Pitchford said she would like to start out by thanking all the elected officials and department directors and managers for all of the work that goes into developing the budget.

Prepared is a highlight sheet which is an overview of the budget. The Budget Message tab in the budget binder details everything that will be reviewed within the highlights portion of this presentation.

Ms. Pitchford reviewed the following:

No changes to property tax levies. There is a 12 cent levy for the General Fund and a 5 cent levy for Road & Bridge.

No changes to county-controlled fees such as building permits, food inspection, animal

control and on-site waste water. The county controls on fees are minimal as most fees are set by state law.

Budget priorities and the impact of those priorities that shaped the budget process and the resulting budget are as follows:

- Maintain fiscal stability within the County's major operation funds
- Implement the results of the County's Salary Plan update along with phase II and provide funding for wage compression and reward of performance
- Implement operation budges for Boone County Joint Communications (911) and Boone County Emergency Management in conjunction with completion of the new Emergency Communications Center (ECC)
- Non-ECC staffing needs such as Public Administrator, Prosecuting Attorney,
 Facilities Maintenance and Grounds
- Provide funding for election activities
- Provide routine replacement of equipment and technology
- Fund routine maintenance and preservation of the County's transportation network

There is a multi-fund composition with 40 plus governmental funds. Five are major funds accounting for 92% of spending and 35 plus funds accounting for 8% of spending. Within this are 10 Internal Service Funds and 3 private Purpose Trust Funds.

The aggregate budgetary comparison for fiscal year 2015 and fiscal year 2016 reflects a 2% increase in total spending within governmental funds. Approximately 60% of operation revenues are legally restricted as a result of statutory provisions or ballot language.

Planned use of the Fund Balance will be appropriated as follows:

General Fund by emergency appropriation, election related costs and equipment

- replacement and non-recurring projects
- Law Enforcement Services Fund will involve vehicle replacements larger than the normal annual budgetary amount
- Community Children's Services Fund resulting in 2015 appropriations not fully spent and will lapse at year-end. Unspent resources accumulate in the fund and a portion of the available fund balance has been appropriated for spending in the 2016 budget.

Fund balances in major operation funds are projected to exceed the minimum 17% established by policy. The minimum fund balance amount ensures adequate cash flow and avoids short-term borrowing costs. Amounts beyond the minimum mitigate risk of revenue volatility, a significant inherent risk whenever sales tax is the primary revenue base. It also provides funding for cyclical expenditures such as elections and equipment replacement.

Full Time Employees have a net increase of plus 16.78. Ten of these are associated with 911/EM services.

There are no outstanding items to be addressed at this time before the Commission approves the budget. The deadline for notifying the Budget Office of revisions to the proposed budget is Friday, December 11th.

Public hearings on the proposed budget have been scheduled for December 1st at 7:00 p.m., December 8th at 9:30 a.m. and December 10th at 1:30 p.m. We are on track to approve the budget on December 17th.

Within the Budget Message tab, there are several schedules noted. This section is intended for a broad audience as a communication device for our citizens. We have a detail of the Revenue Assumptions and Projections with an expected net increase of 2%. Also listed is a detail for the Expenditure Assumptions and Projections and these also are expected to show

a net increase of 2%. Also shown is an analysis of fund balances which is the difference between the assets and liabilities of a particular fund and long-term debt where debt service appropriations amount to \$1.5 million or 1.0% of the total budget. We are well below the Constitutional Debt limit of 10%. We currently stand at 0.6%.

We have noted a section for Capital Projects. This falls within the Capital Projects Budget and must be distinguished from the annual operation budget. The annual operation budget takes effect when the Commission approves the budget and lapses on December 31st. Capital project budget takes effect when the Commission approves the project and remains until the project has been completed. This could span several years.

Lastly, there is a supplemental section which details the 2016 budget supplemental requests within each fund type. These have been approved and are included in the budget.

Ms. Pitchford completed the budget review which will appear in full on the County web site and asked if there are any questions from the Commission.

Commissioner Miller said there have been numerous work sessions and all the questions have been asked and answered in those sessions.

The Commissioners thanked Ms. Pitchford and her staff for compiling such an extensive amount of data in a clear and concise way.

2. First reading; Budget revision to replace outdated equipment in the jail

Jacob Garrett said this budget revision is to replace outdated washers and dryer in the jail.

There were no comments or questions.

Request for Bid 67-09OCT15 – Washers & Dryer for Boone County Sheriff's Department closed on October 9th, 2015. Three bid responses were received. Recommendation for award is MidAmerica Equipment Company for offering the lowest and best bid.

Cost of the contract is \$23,135.00 and will be paid from department 1256 – Sheriff & Corrections Building Maintenance, account 23001 – Replacement Machinery & Equipment. According to Leasa Quick savings from 1255 – Corrections will be used for this bid.

This is a County wide contract. The contract period is from January 1, 2016 through December 31, 2016 and may be automatically renewed for an additional four (4) one year periods.
