7. First reading; Budget Amendment to establish a budget for the purchase of the Rave Alert for Public Safety

Terry Cassil said The Rave alert system is an electronic system that all of our customers throughout Boone County will be able to utilize as a subscriber. They will be able to go in and pick from a menu of things they would like to be alerted on such as weather, shootings

or whatever other questions they may have. This is also the same system that the University is purchasing. They plan on testing this shortly and rolling it out in late May for use by the students when they return in August. This is a great system and people can use it with their smart phone, tablet, home computer or land line.

Commissioner Miller noted this will replace the Nixle system once the Rave system is rolled out and everyone who had signed up for the Nixle system will have to re-sign up with this Rave system.

Mr. Cassil said they are in discussions with Rave now to see if this can be done automatically.

Commissioner Atwill noted that this system was purchased at a bargain.

Mr. Cassil said that Boone County is a Charter 50 member and being one of the first 50 customers, we were able to purchase the system for 50 cents on the dollar. This system will also follow you on your travels if you go to a place that has the system, the alerts will be shown on your device in that area as well.

Commissioner Miller noted that several systems were looked at.

Mr. Cassil said that is correct. With the assistance of Aron Gish and Chad Martin, this system was determined to be the best.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and a public hearing and second reading will occur after the mandatory 10 day waiting period.

First reading; Budget Amendment for Active Shooter Costs and Infectious Disease Kits

Terry Cassil said that Emergency Management has been working on this for the past several years. The active shooter kits are kits our Resource Officers have in the schools so if there is an active shooter situation, the school has these kits for use until it is safe for the fire or EMS to get to them. The Columbia Police Department has said they have already used these kits and believe they have saved a couple of people using them.

The Infectious Disease kits are kits that the Fire Chiefs and Law Enforcement officials have signed off on as something that will meet their needs.

9. Second reading; Video Services Providers Act Franchise Fee Ratification (1st read 3-3-16)

Commissioner Miller moved on this day the County Commission of the County of Boone, to the extent permitted by the 2007 Video Services Providers Act (RSMo Secs. 67.2675-67.2714), does hereby ratify all incumbent cable operator and cable system franchises granted to video service providers operating within Boone County's franchise area as of August 28, 2007, including the County's existing franchise fee of 5% on gross revenues. The County of Boone, as a franchise entity, ratifies all franchises granted to incumbent cable operators through the date of expiration by their own terms, or until those agreements are preempted by the issuance of video service authorizations by the Missouri Public Service Commission, but only to the extent of said preemption. For any new video service providers seeking to provide service after August 28, 2007, only those entities issued a video service authorization by the Missouri Public Service Commission may provide video services in Boone County, and new video service providers shall be subject to the same 5% fee on gross revenues levied on incumbent cable operators as authorized by RSMo Sec. 67.2689.

12. Award Presentation from American Council of Engineering Consultants for innovative design on Rustic Road Bridge Project

Steve Schultz said he is with Bartlett & West and would like to present the County with this award for work on the Rustic Road Bridge project. Bartlett & West was hired by the County for engineering design consultant work. This is a big deal in the circles we work in. This is a grand award for this bridge and the state of Missouri.

What makes this bridge unique and the reason we won the award is there is no cast-in-place concrete which allowed us to build the bridge quickly along with great savings to the county.

Derin Campbell said we received a grant for this project and the University is doing some continued monitoring on it. We receive periodic e-mail updates and every six months will get a report on any movement that we are experiencing on the bridge. So far, it has been pretty minimal.

Commissioner Atwill asked what is so unique about this bridge.

Mr. Campbell said this has a GRS abutment, Geosynthetic Reinforced Soil Integration System. This is a new construction technique that does not require a lot of big equipment. The other thing is that it utilizes a galvanized tub girder design. This is a trapezoidal shape with a long flat bottom. (Mr. Schultz showed the Commission pictures of the bridge and the tub girder design)

Mr. Schultz said the abutments usually come in cast form, poured concrete. With this design, these are big blocks that are laid and behind that is the geo grid, plastic mesh and rock. If these blocks fail, the bridge will still stay because it does not rest on the abutment, but the soil.

Commissioner Miller asked how long do we need to watch this before we will use it again.

Mr. Campbell said he believes we should monitor this for a couple of years.

Commissioner Miller asked about the cost difference between this design and the other, more traditional design.

Mr. Campbell said it varies across the United States. It could be as much as 30%. We did not see quite that much because this was only the 2nd one built and we are still learning how to do this.

The Commissioners congratulated both Mr. Schultz and Mr. Campbell for receiving this award.
