The meeting was called to order at 9:32 a.m.

#### **Family Court Services**

1. First reading; Approve application for Fostering Court Improvement JCIP subgrant

Angie Jacko said every year they apply for this Fostering Court Improvement JCIP sub-grant and the amount for this year is \$2,000. At this point, we have projected to use \$1,200 for lunches for JCIP Court members and contract attorneys and \$800 for training.

We will also have an opportunity, if needed, to apply later for an additional \$1,500 and we will be looking at that.

Commissioner Miller asked what would happen without this additional money.

Ms. Jacko said they would continue the meetings, but without the lunches. Additionally, we are looking at a program called "Walking the Tracks." This will give the different stakeholders in our cases a better understanding and appreciation of the roles each has. This will allow the Guardian ad Litem and Case Manager to observe the issues each have in going

forward with a case and what the day looks like for each one. There are training resources out there for this and one other thing is that there is a possible partnership with other Circuits to pool resources. We are looking to do this with either the 12<sup>th</sup> or 14<sup>th</sup>.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

# 11. 1st & 2nd reading; Approve Change Order #45 for the ECC

Erik Miller said this change order involves three different items. The first item is for a sheet metal shroud we are installing underneath an electrical panel in the storage room which is adjacent to the dispatch area and this is at the owner's request.

The second item is for an appliance installation, an ice maker, in the kitchen. This also was at the owner's request.

The third item is for relocating a thermostat from room 117 to room 119, the multi-media control center, and adding a thermostat and VAV box with electrical re-heat in room 117, Breakout Planning, for proper functionality of the HVAC system. This was an unanticipated need and was not correct in the original design. The multi-media room houses computer equipment which controls audio and visual throughout the building.

Commissioner Thompson asked if this is a permanent fix.

Commissioner Miller said it is.

Commissioner Atwill asked if the cost is all labor.

Mr. Miller said it is broken down as follows:

Miscellaneous Material is \$50

Titus VAV is \$1,264

VAV Labor Installation is \$1,179.52

Supervision is \$216.00

Return to check operation is \$147.44

There is a 20% OH&P charge of \$571.39

The electrical parts are \$309.34

Electrical labor is \$3,353.28
