1. First reading; Cooperative Contract 6-160630LK – On-Line Surplus Auction Service

Melinda Bobbitt read the following memo:

Purchasing requests permission to utilize the Missouri Department of Transportation cooperative contract 6-160630LK to purchase On-Line Surplus Auction Service from GovDeals of Mobile, Alabama. This contract will replace our existing contract with GovDeals. Contract is through August 31, 2019 and has two, one-year renewal periods.

The County will continue to pay a 7.5% commission for surplus items sold on GovDeals on-line auction site and the \$5.00 minimum fee has been waived.

#### 2. First reading; Surplus Disposal – Bilt-Rite metal shed

Boone County Joint Communications requests permission to dispose of a metal shed used as a radio equipment shelter at the DEM tower site. This shed has reached end of life with black mold in the walls. They will be replacing it with a larger shelter relocated from the Prathersville site. Contractor that relocates the replacement shed will dispose of the surplus shed.

## 3. 1st & 2nd reading; Final Post Bond Assessment - Manchester Heights

Commissioner Atwill moved on this day the County Commission of the County of Boone does hereby compute the Final Post Bond Assessment of the sanitary sewer improvement project for the Manchester Heights Sanitary Sewer Neighborhood Improvement District as certified to be \$ 294,502.48.

The County Commission does hereby apportion the cost of said project equally within said district according to the provisions of 67.463.2 RSMO (1993 Supp.) and the terms of the petition approved by said Commission in Commission Order 314-2010.

The County Commission further orders the following:

   "A" and in the attached amounts.
- 2. The County Collector to proceed with collection of said assessments pursuant to the statutory provisions of 67.463 RSMo. The special assessments shall take effect on the 17th day of November, 2016.
- 3. This order and attached exhibit "A" shall be maintained as an official public record with notice of this assessment to be given to all interested parties by recording this order in the land records of Boone County, Missouri.
- 4. The Presiding Commissioner is authorized to execute appropriate notices of liens and the County Collector is authorized to execute releases of said liens, as appropriate, upon collection consistent with the practices and procedures of the Boone County Collector of Revenue.
