1. 1st & 2nd reading; Change Order #3: 06913 - Radio Consoles for the ECC

Contract 06913 – Radio Consoles for the ECC was approved by commission for award to Avtec, Inc. on May 3, 2016, commission order 217-2016. This change order adds additional Avtec Scout radio consoles, maintenance, products, and services for the addition of the 911/Joint Communications Backup Center at 609 E. Walnut.

Management Asset Inventory

Chad Martin said Joint Communications, on behalf of the Office of Emergency Management, is requesting Commission approval of the second and final list of assets, formerly owned by the City of Columbia, to be transferred to the County for the day-to-day operations for the Emergency Communications Center.

Commissioner Miller said this is what Tony St. Romaine had been working on before he left and thanked Mr. Martin for his hard work on cross checking this very large list. These can now be put on our insurance and we will have a complete asset list.

4. First reading; Agreement between Boone County and True North for the purchase of services regarding Emergency Shelter and Supportive Services for Victims of Domestic Violence

Kelly Wallis said this contract is through the Domestic Violence Fund. During the application process, there was only one applicant for the funds, True North. Boone County has contracted with them for multiple years, always meeting their contract obligations and we recommend we contract with them again.

The Children's Services Board decided not to continue contracting with Missouri Girls Town and entered into a separate contract with Presbyterian Children's Homes and Services for Therapeutic Mentoring.

Ms. Wallis said it was because the original contract was signed by Missouri Girls Town. Now, for invoice purposes, we need to contract directly with them.
