7. Second reading; Plan of Merger filed by Boone County Library Board of Trustees and Columbia Library Board of Trustees (1st read 6-20-17)

Melissa Carr said she is here with Susan Daly, President of the Regional Board and we are here to answer any questions the Commission might have.

Commissioner Atwill said that since the press is in attendance, it might be a good idea to give some background on this particular merger.

Ms. Carr said the boards of the Columbia Library District and Boone County Library District have been talking about uniting the two library districts for a number of years. In fact, this merger was included in our strategic plan that started in 2009 and ends this year. The board unanimously voted to put this in the strategic plan and most recently, the board unanimously approved to petitioning the city council and now the County Commission to provide this new library district which will be called the Columbia & Boone County Library District.

What this will do for us is it simplifies the governance of our organization and makes it so that everyone in Boone County, outside of the Centralia Library District, will pay the same tax rate. Our patrons will still be provided the same services, this just forms a new entity.

Commissioner Atwill noted this is sort of a modernization project.

There were no further comments or questions.

Commissioner Thompson moved on this day the County Commission of the County of Boone does hereby approve the Petition for a Plan of Merger filed by the Boone County Library Board of Trustees and the Columbia Library Board of Trustees to create the new, unified, Columbia and Boone County Library District, effective on the close of business on December 31, 2017.

At the expiration of a term of a county-appointed library trustee, the County Commission will by separate Order appoint subsequent Trustees to 3-year terms.
