This will be sent out to make sure there were no assumptions that were not intended or we had mistaken something in their responses.

3. First reading; Change Order #4 to 06913, Radio Consoles for the ECC

Melinda Bobbitt read the following memo:

Contract 06913 – Radio Consoles for the ECC was approved by commission for award to Avtec, Inc. on May 3, 2016, commission order 217-2016. This change order adds

additional Avtec radio hardware and services for \$53,262.97.

Cost will be split between department 4101 – ECC Radio & Technology and 4102 – ECC Backup Center, account 71231 – Owner Costs. \$1.1 million was budgeted for this project.

4. First reading; Cooperative Contract 15-JLP-023, HVAC Products, Installation, Services, and Related products and Services

Facilities Maintenance requests permission to utilize the Board of Education of Harford County, Maryland U.S. Communities cooperative contract *15-JLP-023* to purchase HVAC Products, Installation, Services, and Related Products and Services from Trane U.S. Inc.

This is a term and supply contract and will be paid from department 6100 – Facilities Maintenance, account 60200 – Equipment Repairs/Maintenance.

5. First reading; Contract Amendment Number One to C215036001 – Prosecuting Attorney Case Management System Maintenance and Support

Contract C215036001 – Prosecuting Attorney Case Management System Maintenance and Support was approved by commission for award to Karpel Computer Systems on July 5, 2016, commission order 320-2016. This amendment adds the following:

Law Enforcement Interface for \$5,000 to be paid from department 2905 – LE / Judicial Information Systems – LE Sales Tax, account 91302 – computer software. \$18,900 is budgeted for 2017.

Joint Communications

9. First reading; Antenna Site License Agreement with Ashland, MO

Chad Martin said Joint Communications is requesting Commission approval for this agreement which is two-fold. It firms up the site for our antenna at the water tower site in Ashland and puts this in the County's name. We also need to make some improvements, so this grants us access to make those improvements on the city tank.

There were no comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

10. First reading; City of Columbia Joint Communications Invoice, Jan. – March 2017

Chad Martin said Joint Communications is requesting Commission approval to release the funds to pay for the January – March 2017 invoice from the City of Columbia for our operational costs and occupancy of the city building and using the city network. The amount is \$58,260.82

Commissioner Atwill asked if this is the last one of these.

Mr. Martin said it will be the last one at this amount. Future agreements will be at a lesser amount based upon just usage of the network since we are no longer in the city building.

Commissioner Parry inquired about the costs associated with this amount.

Mr. Martin said it includes I/T costs, using the city printing and postal services as well as custodial services.

There were no further comments or questions.

Sheriff's Department

11. First reading; Budget Amendment to establish budget for portion of Karpel interface project with Columbia Police Department and MU Police Dept.

Captain German said this is coupled with the next item and dovetails into the contract amendment read earlier today by Purchasing. When going through the RMS process, there is essentially a handshake between Karpel and Superion. With this project, we had that portion of the budget for the transfer of data to the PA System (Karpel) and then needed to reach out and firm up an agreement with Karpel to transfer the data. The cost is \$5,000 plus \$1,000 for maintenance which will be split amongst the County, City and MU Police.

There were no comments or questions.

Commissioner Atwill said there will be a second reading after the mandatory 10-day waiting period for budget amendments.

12. First reading; Budget Revision to establish a budget for the County's portion of the Karpel interface project with CPD and MU Police Department

13. First reading; Agreement between Boone County Sheriff's Department and Curators of the University of Missouri providing additional safety and security

Captain German said this is the annual agreement to provide personnel to assist with the football games. It sets the reimbursement at an hourly rate of \$45.

There were no comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

14. First reading; Approve acceptance of the 2018 State Cyber Crime Grant award

Captain German said last year we had put in for this grant and they standardized the benefits they were paying out. That is really the only change they made in cutting the benefits while most of the other things stayed the same with regards to training and equipment. We are excited about the equipment portion of the grant. Our forensic computer will need to be replaced and this grant will make that happen. Once again, it was the benefits that changed. The dental insurance, the subsidized dental insurance, life insurance, long term disability, subsidized medical insurance and the health savings insurance account are what have been removed from the grant.

Commissioner Atwill asked what the value of the grant will be.

Captain German said it is \$201,122.72.

Commissioner Atwill asked if there are any county matching funds.

Captain German said no.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

13th Judicial Circuit Court

15. First reading; Approve agreement for Batterers' Intervention Program

Cindy Garrett said this is from a grant we have had for some time. We had, in the past, contracted with Family Counseling Center, to provide the Batterers' Intervention Program as they were the only agency providing this service. TMT Consulting is now another agency providing this service and have asked to be part of the contract. So, we are asking for a \$40,000 contract with them to provide Batterers' Intervention treatment. That is the remainder of the current award that is not being used by Family Counseling Center.

Commissioner Atwill asked if the county is making a contribution towards this.

Ms. Garrett said the grant is roughly \$212,000 and the county matches about \$80,000.

Mary Epping said most of the matching money comes from the participants who are using co-pay for the treatment.

There were no further comments or questions.

16. First reading; Budget Amendment to increase revenue and expenditures for the Domestic Relations Resolution Fund – Contact for Kids: A Safe Way Grant

Angie Jaco said we have been approved for an award in the amount of \$10,000 for our Contact for Kids: A Safe Way grant. It is a supervised visitation grant for cases involving domestic relations. There has to be an element of domestic assault, a domestic problem in the relationship and typically, the non-custodial parent visits those kids. They provide up to 12 hours of visitation to try to re-introduce the parent and get the family together.

There were no comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.
