The meeting was called to order at 9:30 a.m.

County Clerk

1. 1st & 2nd reading; Acceptance of the Certification of the August 8, 2017 election

Taylor Burks said this is for acceptance of the certification of the county-wide road tax that was approved this past special election.

Commissioner Parry asked about turn-out for this election.

Mr. Burks said county wide it was 14.1%.

Commissioner Parry asked how this compared to the April election.

Mr. Burks said the turn-out for the August election was higher due to, not only the road tax on the ballot, but the 50th district race and the Centralia School Levy.

Commissioner Parry moved on this day the County Commission of the County of Boone does hereby accept the attached certification of election from the County Clerk and Election Authority for Boone County, Missouri. The proposal for a county-wide sales tax, having been approved by a majority of qualified voters voting thereon, the Commission hereby orders the imposition of the county-wide sales tax pursuant to the provisions of RSMo §67.547, in the amount of one-half of one percent for the period beginning October 1, 2018 and ending September 30, 2028.

Said sales tax shall be for the limited purpose of improving and maintaining roads, bridges, and right-of- ways within Boone County. Said sales tax shall be imposed on all sales which are subject to taxation under the provisions of RSMo §§144.010 - 144.527 as amended and, pursuant to RSMo §144.032, said sales tax shall also be imposed on all sales of metered water services, electricity, electrical current, and natural, artificial, or propane gas, wood, coal, or home heating oil for domestic use only.

Commissioner Thompson seconded the motion.

2. 1st & 2nd reading; Abatement of a property located at 1603 E. Tower Drive, parcel #12-417-19-01-039.00 01

Resource Management

7. First reading; Road & Bridge Cooperative Agreement - City of Rocheport

Kelle Westcott said this is one of the four application entities we have an agreement with concerning the Road & Bridge sales tax distribution. The agreement is a six-year cycle and this is the 5th year of the cycle.

There were no comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

8. First reading; Contract Amendment Number One with Engineering Surveys & Services as approved on Commission Order 175-2017

Kelle Westcott said the original contract was for concrete testing that included two private developments that will become Boone County streets. We are adding another subdivision, Settler's Ridge, to that contract as those streets will become county streets as well.

Commissioner Parry said he thought that Settler's Ridge had a pre-annexation agreement to go into the city.

Commissioner Atwill said there has been some difficulty between the developer and the city concerning the sewer.

Commissioner Parry asked if we would still accept those roads.

Commissioner Atwill said that if everything is in order, we don't have a provision to withdraw approval.

Commissioner Parry asked Ms. Westcott to find out about the pre-annexation agreement.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Treasurer

9. First reading; Revision to the P-Card Policy, Section XV

Tom Darrough said the current policy, as written, is very pervasive in its safety mechanisms. Some are cumbersome and costly, one which is that everyone that has a P-Card must take a quiz every year. Our office feels this is not necessary.

When one initially gets this card, a quiz is taken that shows one understands the appropriate and inappropriate use of the card and that they also understand the reporting structure concerning approvals and reconciliation of the card. We have not had any issues that would indicate there is a lack of understanding of that.

Commissioner Thompson said there is also no lack of understanding the consequences for failure to use the card appropriately.

Mr. Darrough said that it is very clear that one is ultimately personally responsible if they use the card for personal reasons. This is not penal, it just reaffirms that they will cover the cost for things that should not have been done. This is straight forward and logical. We will save money by taking this out and we believe there are no consequences to not taking a quiz every year. As we send more and more cards out, it is just more paperwork.

Commissioner Thompson asked if this was done in consultation with the Auditor's Office.

Mr. Darrough said it was just his staff and himself. They discussed the change and presented it to all elected officials and directors. The feedback we received has been all positive on making this change.

Commissioner Atwill noted that the P-Card process has a lot of checks and balances that are unaware to the user. Your office does a lot of background checks as well as checking on charges that come through.

Mr. Darrough said that we require, within the users approval chain, that they have seen it and approve it. There is not just one person above that sees the charges. There often are three levels that see the charges.

There were no further comments or questions.

Commission

13. First reading; Use Tax – Commission Order calling for Election and Sample Ballot for November ballot

Commissioner Thompson said that it is her understanding that, last night, the Columbia City Council approved going forward with the Use Tax for the November election for that jurisdiction. That was one thing we were concerned about, that if we were to move forward in November, that we move forward together with our sister jurisdictions as much as possible. Harrisburg has already issued its Ordinance to have it on the November ballot. That will be three jurisdictions in Boone County.

Commissioner Parry said it is worth noting that the County Clerk made some solid comments and argument for postponing this until April. His concern regarding Special Elections and the use of Special Elections is certainly noted. We are told the School District has an issue on the April ballot and the city is contemplating one as well for law enforcement. So, from the City Manager and Council perspective, this was the best time to do the Use Tax. So, for that reason, it makes sense to go in November, but noting the County Clerk's concern about the cost of the election which is estimated to be between \$180,000 and \$250,000.

Commissioner Thompson said that in terms of the cost of the election, those that attended a presentation last Friday by our Auditor, it was confirmed that waiting only delays our opportunity to collect the tax. In speaking to members of the Columbia City Council, their concern is the same.

Commissioner Atwill said the sooner we get the tax in place, assuming the voters pass it, the sooner we can start the collection process as the revenue is needed.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.
