## 2. Abatement of a property located at 8703 Tom Bass Road, parcel #21-502-15-00-008.00 01

Stephanie Sprock said she believes there was a fire on the property and there is a lot of junk and vehicles on the property. Some people want to sell some adjacent property and this has become an issue when they are showing the property to prospective buyers. She has not been in contact with the owners and it has been posted in the newspaper.

Commissioner Atwill asked if there is anyone present representing the property owner.

Brandy Morris said she is here with her mother-in-law, Gayle Morris, the property owner. She suffered a stroke several years ago and it is sometimes hard for her to hear and speak. We did have a fire three years ago and we did not have insurance and we are trying to come up with the money to get it cleaned up.

We were working on it ourselves and then my husband broke his back and we could not continue. We are getting numerous estimates, starting this Wednesday, to get the grass cut as well as getting the area cleaned up. We are asking for a little more time.

Commissioner Parry asked how much more time is needed.

Ms. Morris said three to six months would be great. If we could at least get three months and then see what is left, that would be greatly appreciated.

Commissioner Thompson said what is often done is we put the order into effect and then you work with the Health Department to make sure things are progressing. They don't act on the order, but it is there. That way you can work together to resolve the issue.

Commissioner Parry said he is sorry for these challenges and we are willing to work with you.

There will be costs

for a consultant to make the interface happen and operate on behalf of the monitoring service, but I do not have a quote for that just yet. It appears they will not provide much more information until we agree to these terms.

The terms basically say that we understand that if the interface goes down, we are going back to a telephone system. It requires us to maintain a public safety answering point, having people answer phones, basically do what we are doing today.
