1. Public hearing - FY2018 County Budget

June Pitchford said this is the 3rd and final public hearing. The proposed budget and three-page highlight document are available on the web site. We have fielded several internal questions on the proposed budget. Prior to adoption of the budget, we are required to post/publish all changes to the proposed budget. There are a couple of tweaks that need to be done. Once those changes have been made, we sit down with County Commission to review those changes and state law requires that we publish those. We are anticipating final budget approval for December 19th.

Commissioner Atwill opened the public hearing and asked if there is anyone present that would like to comment on the budget. There were no speakers and Commissioner Atwill closed the public hearing.

2. 1st & 2nd reading; Abatement of a property located at 1603 W. Tower Drive, parcel #12-417-19-01-039.00 01

Kris Vellema said that we abated this property earlier this year and the photos shown are from that earlier abatement. This is just more of the same. We have spoken many times with the owners and have not gotten any results.

Commissioner Parry asked who the person in the photo would be.

Ms. Vellema said it is one of the owners of the company that hauls the junk from these properties. We talked to them on the best way to handle this clean-up. They suggested bringing in a dumpster or two and a skid loader as quickly as possible as weather is a concern. We have received an estimate between \$2,800 and \$3,500.

Commissioner Atwill asked if they have the budget for that kind of expense.

Ms. Vellema said that her supervisor assured her they can afford it at that price.

Commissioner Parry inquired about the last photo.

Ms. Vellema said it is standing water with mosquito larva. It is a breeding ground for mosquitoes.

Commissioner Atwill noted there is no owner representation here at the meeting.
