1. First reading; Contract Amendment #1 to 39-28SEP17 – Forensic Workstation for the Sheriff's Department

Melinda Bobbitt read the following memo:

Contract #39-28SEP17 for a Forensic Workstation for the Boone County Sheriff's Department that was awarded November 7, 2017 (Commission Order 501-2017) is being amended to delete the portion of the contract that includes reference to and terms for the Federal Grant Requirements for the Multi-Jurisdictional Cyber Crimes Grant. The purchase is covered under the State of Missouri Cyber Crimes Grant, not the referenced federal grant which was referred to in error and only discovered after the award had been made. Amendment #1 corrects the error by deleting the federal grant terms.

All other terms, conditions and pricing of the original agreement remain unchanged.

2. First reading; Contract Amendment Number One to 54-18DEC15 – Electronic Media Storage

Contract 54-18DEC15 – Electronic Media Storage was approved by commission for award to Underground Records Management, L.L.C. of Columbia, Missouri on January 19, 2016, commission order 24-2016. This amendment adds the Emergency Communication Center as an additional pickup center location with pick-up one time per month for an estimated 15 electronic media/month.

Invoices will be paid from department 2703 – Information Technology – Boone County Joint Communications / Emergency Management, account 71100 – Outside Services. \$2,000 is budgeted for 2017.
