Resource Management

 Second reading; Update authority validations to sign change orders for road & bridge construction, road & bridge design and facility improvement projects per revised Purchasing Policy revisions and rescind Commission Orders 343-1996 and 178-2001 (1st read 1-23-18)

Commissioner Thompson moved on this day the County Commission of the County of Boone does hereby authorize the liaison Commissioner for Public Works, Facilities Maintenance, and Resource Management to sign change orders for road & bridge construction, road & bridge design, and facility improvement projects up to 5% of the project cost per change order, not to exceed the cumulative contingency. The contingency is defined as "The contract contingency or 10% of the contract cost." Any change order in excess of the contingency must be accompanied by a new Commission Order.
