Proclamation

1. Proclamation recognizing the deserved accolades of Stanton Brothers Eggs

Commissioner Thompson that these two young men are an asset to our community and read the following proclamation:

Whereas, Stanton Brothers, owned and operated by Dustin and Austin Stanton, began out of a first grade 4-H poultry incubation project, which Stanton Brothers began with six baby chicks and selling eggs to residents of Boone County; and

Whereas, through Dustin and Austin's innovation and entrepreneurial spirits, as well as help from their parents, Andrew and Judy Stanton, Stanton Brothers has grown to be recognized by the USDA as the nation's largest independent free-range egg operation; and

Whereas, Stanton Brothers has brought national notoriety to Boone County by hosting the likes of United States Senator Claire McCaskill, United States Representative Vicky Hartzler, and Facebook Founder and CEO Mark Zuckerberg; and

Whereas, Dustin and Austin, combined, have received numerous national honors for their work with Stanton Brothers, including the 2011 National Risk Management Award from the USDA, the 2014 American Star in Agribusiness Award from the National FFA Organization, and the 2015 President's Student Entrepreneur of the Year Award from the University of Missouri; and

Whereas, Dustin and Austin have been international representatives of Boone County by traveling to venues such as Costa Rica to apply learned business skills in their egg operation and Japan to serve as a liaison for the US Grains Council for passage of the Trans Pacific Partnership; and

Whereas, Dustin and Austin are actively involved in the Boone County community through their personal volunteerism and humanitarian efforts, as well as volunteering through different civic organizations such as Farm Bureau, MU Extension, Young Farmers, FFA, FBLA, and the Hallsville Church of Christ; and

Whereas, Dustin and Austin serve as a positive influential voice for entrepreneurialism, the agriculture industry, and the Millennial generation;

Therefore, we, the Boone County Commission, do hereby recognize Stanton Brothers for all its contributions to Boone County and extend congratulations to Dustin, Austin, Andrew and Judy Stanton for their personal drive to better Boone County for all residents.

3. First reading; Cooperative Agreement with the City of Columbia for Public Health Services

4. First reading; Cooperative Agreement with the City of Columbia for Animal Control Services

Purchasing

First reading; NJPA Cooperative Contract 113012 – Purchase VTL Road
 Maintenance Equipment with Related Accessories, Services, and Supplies and dispose of one (1) D-550 Truck with attached paver

Liz Palazzolo read the following memo:

Public Works requests permission to utilize the National Joint Powers Alliance (NJPA) cooperative contract 113012 - VTL to purchase one (1) VT Leeboy 7000C Paver from Roland Machinery Company.

Cost of the purchase is \$120,950 and will be paid from department 2040 – PW Maintenance Operations, account 92300 – Replacement Equipment.

This is a replacement purchase and the 2018 budgeted amount was \$125,000. Budgeted sale value is \$3,500, yielding a net cost of \$121,500.

The contract price is \$120,950 minus the sale price of \$2,500, yielding a net cost of \$117,450.

The Purchasing department requests permission dispose of the following surplus: 2008 Layton D-550 truck attached paver with fixed asset tag 16563

6. First reading; Contract Amendment Number Two to C.O. 137-2015 – Cost Allocation Plan Consulting Services

Contract *C.O.* 137-2015 – Cost Allocation Plan Consulting Services was approved by commission for award to MAXIMUS Consulting Services, Inc. of Springfield, Illinois on March 31, 2015, commission order 137-2015. This amendment adds a clause for a copyright for the Contractor's proprietary software. It also renews the contract through December 31, 2018.

Invoices will continue to be paid from department 1190 – Non-Department, account 71101 – Professional Services.

7. First reading; Cooperative Contract C215091001 – Livescan Fingerprint Equipment and Maintenance with Morpho Trak for Court Administration

Liz Palazzolo read the following memo:

Mary Epping with Court Administration requests permission to utilize the State of Missouri cooperative contract C215091001 to purchase Livescan fingerprint equipment from MorphoTrak, Inc. of Anaheim, California.

Equipment will be purchased from department 1210 – Circuit Court Services, account 71600 – Equipment Leases & Meter Charge. \$2,947 is budgeted for 2018. The MorphoTrak booking station subscription with maintenance is \$5,250/year and the Mug-Phot Capture is \$664/year. The MO Highway Patrol paid for the first year with grant funds for the period ending June 30, 2018. Our cost will be \$2,957 for July 1, 2018 – December 31, 2018.

Commissioner Thompson asked if this is a one-time grant award.

Cindy Garrett said it is. (Could not hear if she did confirm this)

8. First reading; Contract Amendment #1 to 48-31AUG15 – MDC-GPS Vehicle Tracking and Fleet Management System

Liz Palazzolo read the following memo:

Contract 48-31AUG15 for an MDC-GPS Vehicle Tracking and Fleet Management System for Public Works and Resource Management that was awarded November 24, 2015 (Commission Order 557-2015) is being amended to assign the contract from CalAmp Radio Satellite Integrators, Inc. to CalAmp Wireless Networks Corporation per the attached letter from Mr. Brian Burda of CalAmp dated December 19, 2017.

All other terms, conditions and pricing of the original agreement remain unchanged.

There were no comments or questions.

9. First reading; Budget Amendment to cover the remaining costs for the bench renovations

Cindy Garrett said we had previously budgeted \$59,400 for bench renovations. Outside of that contract, we needed to pay for data lines and re-wiring of jacks and are asking to amend the budget to add the additional \$2,550 to pay for the added work.

There were no comments or questions.

Commissioner Atwill said a public hearing and second reading will occur after the mandatory 10-day waiting period for budget amendments.

10. First reading; Tax Collection Agreement between Downtown CID and Boone County

Brian McCollum said this is one of several agreements in the next couple of months as we are updating our Collection Agreements with all the taxing entities. This current one is for the city. The purpose, since the library is a stand-alone entity now, is to pull that portion out of the agreement.

There has been a statutory change to some of the penalties and late fees we collect. The penalties and fees do not go to the Downtown CID, but it is referenced in the Collection Agreements and that is the reason we are updating at this time.

Commissioner Parry asked if any other taxing districts will be affected by the Library change.

Mr. McCollum said no.
