Health Department

2. First reading; Cooperative Contract C215080010 – Purchase Photocopier and Maintenance for Prosecuting Attorney and dispose of one (1) Canon copier

The Boone County Prosecuting Attorney IV-D Child Support Enforcement Department requests permission to utilize the State of Missouri cooperative contract C215080010 (pricing based on NASPO Value Point contract 3091) with Image Technologies of Columbia, Missouri to purchase one photocopier with maintenance.

Cost: \$4,973.69

This is a replacement purchase and the 2018 budgeted amount was \$274,000.00. Budgeted trade value is \$85,000.00, yielding a net cost of \$189,000.00.

The contract price is \$267,660.50 less the trade price of \$85,500.00 and 5YR/2500 PT/Hyd Warranty at \$2,873.00, yielding a net cost of \$179,287.50

Cost of services is \$2,300 and will be paid from 2706 – Radio Network Improvements, 71101 – Professional Services. \$6,000 is budgeted for the Pole Barn Radio Tower Project.

Office of Emergency Management

7. 1st & 2nd reading; Approve application for the Emergency Management Performance Grant

Tom Hurley said this EMPG is due this Friday. It is an annual grant and provides half the funding for the Director, Assistant Deputy Director and Administrative Coordinator positions including wages and benefits. There is a small portion left over and it is used for maintenance.

Without a Director's position at present, we put in for ³/₄ position for that role and the balance of that will be spent on fire maintenance. This is a 50/50 match and we are compliant in all phases.

Commissioner Parry inquired on the amount.

Mr. Hurley said it is for \$121,000 and the state has assured us, given our position without a Director, any funds not allocated will not be used against us as a reduction in the future.

Commissioner Thompson asked on the submittal of the application.

Mr. Hurley said as soon as it is approved. It is due this Friday.

Joint Communications

8. First reading; City of Columbia Joint Communications Invoice, October – December, 2017

Chad Martin said Joint Communications is requesting Commission approval to the invoice submitted by the City of Columbia for the October – December, 2017 time period. The amount is \$25,694.86 and covers support and housing of the computer infrastructure.

Commissioner Atwill asked if this is the last of these payments or is it every month.

Mr. Martin said there will be another one for January. We still have pieces we are clearing out and Aron is working with the City and their IT Director.

Commissioner Parry inquired if they are charging us rent for a computer that we are using to provide them with 911 services.

Mr. Martin said yes. There are fiber optic fees for the connection and IT support because the hardware and portions of the server are there as well as a small fee for various other connections.

Commissioner Parry said that, in the near future, he would like to get a running total of how much relief we have given the city on 911 services over the last three years.

Mr. Martin said he will need to compile those numbers.

Commissioner Atwill said you also might want to look at the value of their use of the computer center at the 911 facility.

Mr. Martin said he will talk to Aron on that.

There were no further comments or questions.

Treasurer

9. 1st & 2nd reading; 2017 Tax Sale Surplus to Amal A. Alroomi in the amount of \$264,737.48

Tom Darrough said we will make the payment to the Collector who will then take care of some outstanding debt and then make the payment.

Commissioner Parry noted that this was the property sold on the Courthouse steps back in August and that he thought they had to wait one year.

C. J. Dykhouse said this property was presented by the Collector at the tax sale in August of 2017. For this one-year period, it states that any time within that one-year period, the owner or owner of record has an exclusive right to redeem the property. That is what has happened here. The owner is applying for the tax surplus which is part of the program where the Commission is usually involved.

She has explicitly applied for the surplus and then have it applied to the amount she needs to redeem the property from the Collector. In the draft summary order, there is different language where it is mutually agreed between the Treasurer and Collector, where the amount will be paid to the Collector and then the Collector will provide the final amount due for the

redemption. Mr. Simon's office, on behalf of Ms. Alroomi, has sufficient funds in the attorney trust to effectuate the redemption which will remove the Tax Certificate Sale from the land records and restore status and title as it was prior to the sale.

The high bidder at the tax sale, what they are entitled to, is the money they paid for the taxes, and some rate of return on the money due on the taxes and 100 cents on the dollar for the amount of the bid over the tax sale.

Commissioner Parry asked who found the owner.

Mr. Dykhouse said she found us and hired counsel to facilitate this.

There were no further comments or questions.

Commissioner Parry moved on this day the County Commission of the County of Boone does hereby approve the disposition of surplus, per attached summary order description, to Amal A. Alroomi in the amount of \$264,737.48.

10. First reading; Stormwater Security Agreement with Schlacks Rentals, Inc.

Nikki Fuemmeler said this relates to the equipment. They have submitted all the required documents and all is approved. We just need to accept the security deposit.

11. First reading; Abell Acres Subdivision Plat 1 Development Agreement

Bill Florea said the plat of Abell Acres was approved October 19, 2017 by the Planning and Zoning Commission with a condition that the plat will not be submitted for approval until the outstanding issues regarding sewer service to the lots is resolved.

The subdivision is proximate to Cedar Gates Wastewater Treatment facility that is owned and operated by Boone County Regional Sewer District.

The facility has sufficient capacity for the four lots in Abell Acres.

A sewer main extension is required to be installed by the sub-divider at an estimated cost of \$21,378.25.

The sub-divider has proposed to guarantee construction of the sewer main with an irrevocable letter of credit in the amount of \$21,378.25. The development agreement on your agenda today, outlines the terms and conditions under which the letter of credit will be accepted. The sub-divider will have one year to complete the sewer main extension.

Approval of the development agreement and acceptance of the letter of credit will allow the plat to be recorded prior to the installation of the sewer main.
