The meeting was called to order at 1:33 p.m.

Purchasing

1. First reading; Disposition of Surplus Equipment by Auction

Melinda Bobbitt read the following memo:

The Purchasing Department requests permission to dispose of the following list of surplus equipment by auction on GovDeals or by destruction for whatever is not suitable for auction.

Ms. Bobbitt said these are the iPads used by the County Clerk.

Commissioner Parry said the County Clerk noted these are good iPads with less than 3 hours usage.

Commissioner Thompson said that the IT Department said we can't support them. It would be more expensive to keep them.

Commissioner Atwill asked why other departments can't use them.

Commissioner Thompson said that Aron has noted that the cost associated is high to support them.

Commissioner Parry said he believes there are different departments that could use them.

Commissioner Thompson said it comes down to a cost-benefit situation.

Commissioner Atwill asked Greg Edington if Public Works could use them.

Greg Edington said he was told by IT that the operating system could only be upgraded to a certain level which is outside the security boundaries where they would feel comfortable.

Boone County Circuit Clerk office requests permission to utilize the State of Missouri cooperative contract C215080007 (pricing based on NASPO Value Point contract 3091) with Marco Technologies, LLC of Columbia, Missouri to purchase photocopiers with maintenance.

Replacement Office Equipment and 60050 – Equipment Service Contract. \$\$11,500 was budgeted for the two copiers.

4. First reading; Contract amendment number one to 76-30NOV15 – Crushed Stone Aggregate

Melinda Bobbitt read the following memo:

Contract 76-30NOV15 – Crushed Stone Aggregate was approved by commission for award to Mid-Missouri Limestone, Inc. on January 14, 2016, commission order 22-2016. This amendment is for an Agreement and Consent to Assignment of Contract from Mid-Missouri Limestone, Inc. to Con-Agg of MO, LLC for Millersburg and the Riggs Quarries.

Invoices will continue to be paid from department 2040 – Public Works – Maintenance Operations, account 26200 – Rock and 26201 – Rock – Vendor Hauled.

Commissioner Parry said there have been rumors that a price increase is coming. Does the contract allow for some flexibility in that pricing structure.

Ms. Bobbitt said it is a one-year renewal and the price increase cannot be greater than 10%.

Commissioner Parry asked if that is by the load, or by pounds.

Greg Edington said it is priced by the ton.

Commissioner Parry asked what the price would be if it went up the 10%.

Greg Edington said the average is \$9/ton. If one where to go out on bid now, the price would be much higher than the 10%.

Commissioner Parry noted that is because there would be no competition.

Commissioner Atwill noted that if we pay \$1 million for rock now, that would amount to an additional \$100,000. This accelerates my interest in mixing clay and rock for a more durable road. With more durable roads, we would need less rock.

There were no further comments or questions.

5. First reading; Professional Service Contract 05-31DEC18C – Legislative Consultant Lobbying Services with Grote & Associates, Inc.

Melinda Bobbitt read the following memo:

Attached for signature is a professional services contract for the furnishing and delivery of legislative consultant lobbying services. Contract is with Grote & Associates Inc. of Columbia, Missouri.

Consultant services are \$26,728 per year with a not to exceed \$2,500 for reimbursable expenses. Invoices will be paid from department 1121 – County Commission, account 71101 – Professional Services. \$36,000 is budgeted.

Ms. Bobbitt said the delay in the insurance certificate was the reason this was pushed back.

6. First reading; Professional Service Contract 10-31MAR18C – Consulting Services for Radio Tower Project for Boone County Barn with K&K Environmental, LLC

Dave Dunford, on behalf of Boone County as our Radio Consultant, requests consulting services for the radio tower project for the Hallsville Maintenance Building and Pole Barn with K&K Environmental LLC of Leavenworth, Kansas.

Cost of services is \$4,850 and will be paid from 2706 – Radio Network Improvements, 91300 – Machinery & Equipment. \$504,194 is budgeted for the Boone County Barn (BCB) Radio Tower Project.
