It sets up the responsibilities of the agencies and establishes that Callaway County will be the lead agency in the design, bidding, and construction of the bridge. Boone County will no longer be the maintenance custodian at the end of construction, it will be Callaway County's bridge at that point. The responsibility of Boone County is the \$85,000 cost match.

Commissioner Atwill said he received a call from the Presiding Commission of Callaway County and they have finished the documents they were required to do and have forwarded them to C. J. this week.

Commissioner Thompson said the wedding had already been approved when they had asked for the 3/23 - 3/31 time period, so the dates needed to be changed. Also, this will make those in wheelchairs have to go around the closure, so the quicker we get done, the better.

Mr. McCollum said we are hoping this is no more than 3-4 days.

Mr. McCollum said there will be detour signs posted with additional signs on both sides.

Commissioner Thompson said that is the real concern, because everyone else can get around the closure much more easily.
