#### Collector

9. First reading; 2012 Tax Bill Year; remove from delinquent tax rolls property tax balances on real estate and person property

Brian McCollum said this is the annual order review to remove the oldest tax bill records from the tax files and that year is 2012. The total amount is \$114,112.08 and the breakdown is as follows:

•	Personal Property	\$81,907.34
•	Bankruptcy and/or probate	\$ 7,168.06
•	Tax exempt acquisitions	\$25,036.68

We also added back 2011 and prior tax bills that were previously stricken from the delinquent tax rolls. The amount of \$6,056.88 were added back to the delinquent tax rolls and collected and distributed to the taxing entities during the period of March 1, 2017 through February 28, 2018.

The majority, as noted, is the Personal Property in the amount of \$81,907.34. Due to the transient nature of Boone County with the Colleges and University, that number is usually high. Once they move out of state, it takes time to track them down with the hope of getting them back on the rolls.

Commissioner Parry asked about the collection rate.

Mr. McCollum said it is generally around the 99.7% rate and when you factor in the real estate, it is usually at 99.99% rate.

Commissioner Thompson asked what efforts are made for those out of state collections when the students take off.

Mr. McCollum said we have several tools such as skip tracing, delinquent tax bills and in some instances, we look for a current address and send out 30-day demand for payment letters, all working with the County Counselor's office. This is a dedicated collection effort throughout the entire year. It's a little harder if they are outside of Missouri and we do have relationships with other Missouri counties.

Commissioner Thompson asked if NACo resources are ever used.

Mr. McCollum said we look at DOR files, voter registration rolls, lexis/nexis as well as some other things. We have various things in our tool box to accomplish this.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

## 24. First reading; Approve Chapter 100 Industrial Development Plans and Bonds for Smith & Wesson Corp., a/k/a American Outdoor Brands

C. J. Dykhouse said this relates to the Chapter 100 application that the Commission approved on April 18, 2017, Commission Order 203-2017 for the American Outdoor Brands incentive. That came before Commission with a unanimous recommendation from the taxing entities review panel and was approved in concept in Commission Order 203-2017.

Because of the way Tax Days fall, the relevant measure dates for property assessment, the Real Estate portion of the AOB Chapter 100 occurred before the end of last year because the relevant date for that was January 1, 2018. We will be doing the Personal Property Chapter 100 this year because the relevant Tax Date for that will be January 1, 2019.

Bond Counsel will be here Thursday for the public hearing and second reading and will be available for any questions with respect to the documents. In your packet is a cover letter from Bond Council dated March 27, 2018, addressed to Commissioner Atwill, which describes each of the documents they are asking Commission to sign and a recommendation for signature. After the public hearing and meeting, with your anticipated approval, Bond Counsel will be taking the signed documents back to Kansas City for a closing on this bond on April 6, 2018. We anticipate a short public hearing and presentation from Bond Counsel.

Commissioner Atwill said he would like to reference the last paragraph in the letter from Bond Counsel which states:

We have either prepared or reviewed the documents you are being asked to sign and are of the opinion that you should now sign where indicated. The documents will be held in escrow, pending my confirmation that all closing requirements have been satisfied.

That is a very important addition as it was not always presented to us that way.

Commissioner Thompson said that is a testament to the Presiding Commissioner and County Counselor for that added protection.

Mr. Dykhouse said that Bond Counsel always works on our behalf, but also with a duel representation, representing the interests of the future bond holder and they are required to tell us if those interests diverge. Jim Caldwell has done a good job for Boone County as our contracted bond counsel.

Commissioner Parry asked the County Counselor for his professional/personal opinion on the Cost/Benefit Analysis that was included in the packet of documents.

Mr. Dykhouse said it is along the lines of the industry standard as an acceptable Cost/Benefit analysis as contemplated in the Chapter 100 statutes, but it is essentially a fiscal impact analysis where the focus is on the impacted taxing entities. It is a Cost/Benefit analysis as contemplated in the Chapter 100 statutes, but we know from our Economic Development experts, they would call this fiscal impact analysis, and not one that addresses the spurred economic activity or job creation or any of those things.

This is strictly a fiscal impact on the taxing entities and what would happen without the abatement and with the abatement and the total cost. There is an inference from the application submitted, April 2017, that this economic activity would not have occurred but not for the County Commission granting approval of the 50% abatement on Personal and Real Property.
