# 6. First reading; Tax Collection Agreement with the city of Hallsville

Brian McCollum said another one of their updated collection agreements. This time with the City of Hallsville. We're slowly getting these knocked out and getting them updated and

signed. Again, like the others, no major changes to the services, the County will offer to the City of Hallsville, and is edited as a result of statutory changes and updating elected official signatures.

# 7. First reading; Budget Amendment for covering the transfer of the excess tax maintenance fund balance fund

Brian McCollum said this is the annual review of the balance that's currently in the Tax Maintenance fund. Per Missouri law revised statute 52.317, any amount that is over the statutory requirement or the statutory cap that we can have in there, is turned over the County General Revenue. To accomplish this, we go through the budget amendment process identifying that dollar amount that's going to be moved from the Tax Maintenance fund over to County General Revenue and the year ended for 2017, we're looking at a transfer of \$55,116 moving from Tax Maintenance fund to County General Revenue.

Commissioner Parry said I'm trying to figure out why it's been listed twice as two transfers to increase for a total of \$110,000.

Brian McCollum said we are updating the expense account in the Tax Maintenance fund, the 21108397, that amount was not currently budgeted as an expense in Tax Maintenance fund budget. So, we are increasing that expense account and we're off-setting that with an increase to corresponding revenue account in department 1190. So, it's an increase in expense on one side and an increase in revenue on the other side.

Commissioner Parry said okay.

Commissioner Thompson said just to make sure, you said \$55,116, or was it 15?

Brian McCollum said \$55,116.

Commissioner Parry said ours say \$15 for some reason

Commissioner Thompson said okay, so the memo needs to be adjusted a bit.

Commissioner Parry said it looks like it's hand-written in here, Brian. That 5. Does yours have hand writing on it?

Commissioner Thompson said yes. It's kind of funky.

Commissioner Parry said on the request for budget amendment.

Commissioner Thompson said this one, the last digit is whited out.

Brian McCollum said unless the Auditor's office made a change to it that I'm not aware of.

Commissioner Thompson said okay, you might want to check with Karen.

Brian McCollum said yeah, it was submitted as \$116, but we'll take a look at that.
