3. First Reading; Contract Amendment: Amendment 2 to Contract #79-15DEC15 –
Law Enforcement Boots – Term & Supply

Melinda Bobbitt read the following memo:

Amendment #2 to contract #79-15DEC15 – Law Enforcement Boots – Term & Supply that was awarded April 28, 2016 (Commission Order 207-2016) is being amended to allow a substitution for item 4.12.4 from the Under Armour Valsetz Tactical Boot (Style 1224003) to the Under Armour Valsetz 1.5 Tactical Boot at the same price. All other terms and conditions of the original agreement as renewed remain unchanged.

4. First Reading; Budget Revision: Transfer funds to replace broken letter opener

5. First Reading; Boone County Road & Bridge Improvement/Repair Cooperative Contract: Village of Hartsburg

Stan Shawver explained this is the cooperative agreement that leads to distribution of sales tax money to the entities. Hartsburg is one of the application entities, and they will be receiving a check in the amount of \$8,301.96. The distribution will start early in the fourth quarter.

Commissioner Thompson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

6. First Reading; Boone County Road & Bridge Improvement/Repair Cooperative Contract: City of Sturgeon

Stan Shawver explained this was the same type of agreement as the last item discussed. The City of Sturgeon will be getting a check in the amount of \$30,717.24.

Commissioner Thompson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

7. Public Hearing and First & Second Reading: Road Closure of Old Coates Lane at Gillespie Bridge Road

Jeff McCann explained that they have the recommendation to hold a public hearing to close the portion of Coates Lane that is just off the west end of Gillespie Bridge Road. Both our department and Public Works have received numerous complaints about trash being dumped at this location. The proposal is to hold the public hearing to officially close the area and extend the guard rail across the opening to hopefully prevent that from becoming a dump site.

Natalie Meighan said at this point the road is not County maintained, it has not been for many years. We have notified all landowners within one thousand feet, and I personally spoke with everyone who is adjacent to that and we have heard no concerns from the landowners. Everyone was grateful for the closure.

There were no comments or questions from the Commission.

Commissioner Thompson opened the public hearing.

There was no one present from the public to speak on this matter.

Commissioner Thompson closed the public hearing.

Commissioner Parry moved on this day the County Commission of the County of Boone

does hereby approve the closure of Old Coats Lane located in the SW 1/4 of Section 20, Township 48 North, Range 13 West. The section of road being closed by this action is at the intersection with Gillespie Bridge Road. This section of Old Coats Lane is not publicly maintained and closing this intersection will not deny access to any property owner to a public road.

The Commission further states that an appropriate traffic control barrier may be placed to impede traffic from access to the closed section of roadway.

A map showing the closed intersection is attached to this order.
