It is further ordered the Boone County Commissioners are hereby authorized to sign the commission for Marc Spickert to serve as Commissioner of Centralia Special Road District for a three-year term.

### **Emergency Management**

4. First Reading; Budget Amendment: Appropriate Funds for 2019 to Award Bid for Purchase of Generator

Tom Hurley explained this was a request to transfer funds from the 2018 budget year to the 2019 budget year in the amount of \$41,350. This was an oversight on not going through the procurement process quickly enough to get the purchase completed prior to the completion of 2018. There is a bid that meets the requirement for the trailer-mounted generator. The request is only to transfer funds from 2018 to 2019, not increase funds.

Commissioner Thompson asked if this was the type of generator that was taken out to Broadway Christian Church when the emergency shelter was established there during the power outages due to one of the recent snow storms.

Tom Hurley said it is similar to that one.

Commissioner Atwill asked at what point does the County feel satisfied that there are enough generators, if ever.

Tom Hurley explained that the County was likely there, but the problem that remains is the ability to plug the generators into buildings. The buildings have to be wired prior to an event to accept the generator. Locally, it is not to that point. Emergency Management Operations is currently looking into mitigation funding from the State to set it up for shelters.

Commissioner Thompson said there is a need to be proactive then with the buildings that are most likely to be utilized as shelters.

Tom Hurley said that is correct. Anecdotally, it has been said that it would cost somewhere between \$15,000 and \$30,000 to wire a building. So, it is not a cheap thing to do. It has not been looked into yet, so he cannot say for sure if those numbers are accurate.

Thaddeus Yonke said that sounds about right for that kind of modification to a modern building. If it is an older building, it may cost more.

Commissioner Thompson said the first step would be to identify those buildings that should be retrofitted.

Hurley said agreed saying that amount of money were to be spent, it would also be wise to enter into some memorandum of understanding with those organizations. That is something

that would be high on the priority list for mitigation dollars, but at the same time, mitigation dollars, both at the State and Federal level, are virtually non-existent.

Commissioner Thompson asked, when there was the event that a generator had to be taken to Centralia, if that building had the ability to plug in or not.

Hurley said they did not. They had a pro-active neighbor who was an electrician that was able to wire it just in time to accept the generators to run critical infrastructure: things such as oxygen tanks and refrigeration for diabetic drugs. It was not the entire facility, so the air conditioner didn't work. It was essentially just the ability to run extension cords to a smaller generator that could feed a refrigerator and oxygen tanks, but not the entire structure. On the municipal side, their waterworks facility was wired to accept a generator, so that was able to be done. Their community center was as well, so that was able to be set up as an evacuation location for that event.

There were no more comments or questions from Commission.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

## **Purchasing**

5. First Reading; Bid Award: 49-07DEC18 - 60kW Trailer Mounted Generator

Melinda Bobbitt explained this is the generator that Emergency Management just submitted the budget amendment for. The second reading for this item will travel with the budget amendment.

Melinda Bobbitt read the following memo:

49-07DEC18 – 60kW Trailer Mounted Generator opened on December 14, 2018. Eight (8) bids were received.

Emergency Management recommends award by low bid to Roland Machinery Company of Bridgeton, Missouri to purchase one (1) Doosan G70WDO-T4F.

Cost of the purchase is \$41,350 and will be paid from department 2702 – Emergency Management Operations, account 91300 – Machinery and Equipment.
