# 3. First Reading; Budget Amendment: Cover Cost Overages for August Primary & November General Elections

Brianna Lennon explained this is a companion to the last item. This would be for the total amount of overages which is \$148,015. Putting the Emergency Funds amount together with this budget amendment which is the transfer of \$51,350 and the appropriation of \$47,815 gets it where it needs to be to cover overages.

Commissioner Thompson wanted clarification on the total amount as the paper for the budget amendment says \$146,980 but Lennon said \$148,015.

Jason Gibson explained the \$146,980 is just the total for that column. The \$48,850 from Emergency plus the \$99,165 that is going into the County Election Expense is the \$148,015.

To get to that amount, \$47,815 is being appropriated in revenue. The shifting of funds are the next lines down, and they are being decreased and put into the Election Expenses. It is all of them combined.

# 6. First Reading; Budget Amendment: County to Act as Lead on Intergovernmental Agreement for Macroinvertebrate Project

Bill Florea explained this item is linked to the next item which is an intergovernmental agreement. Under that agreement, the County would be the lead on the project and would be reimbursed by the other entities which are the University of Missouri and the City of Columbia.

Florea read the following staff report that serves as background for both item number six and seven on the agenda:

This is an agreement with the University of Missouri and the City of Columbia to fund a study to conduct an in-depth and targeted analysis of existing macroinvertebrate data collected by Missouri DNR to diagnose stressors that are causing aquatic life impairment in Hinkson Creek.

The study was suggested by the CAM Science Team and endorsed by the CAM Stakeholder Committee. The University and City have each signed the agreement.

The not to exceed amount of \$99,000 will be split evenly between the three entities as stipulated in the existing Intergovernmental Cooperation Agreement (Order 163-2013, April 2, 2013), and in this proposed agreement.

The results of the study are due no later than one year from the contract award date and will include recommendations of specific management alternatives for enhancing, maintaining, and preserving the integrity of macroinvertebrate communities in Hinkson Creek. Deliverables will include:

- Monthly project status meetings with the contractor
- Development of a database containing results of the analyses
- An interim presentation to the CAM Stakeholder Committee, Science Team and Action Team
- A final report and presentation to the three CAM groups

Purchasing has completed preparation of the Request for Statement of Qualifications. If this agreement is approved by the Commission, the procurement process will start with publication of the RSQ for 45 days. The University and City will be invited to participate in the consultant selection process.

Commissioner Parry said a couple of stressors on Hinkson Creek are sediment and temperature and asked Lynne Hooper if chlorides were a stressor as well.

Lynne Hooper explained that Dr. Hubbard has done a study that did indicate chlorides were a stressor. There are some other things going on that are a mystery. The purpose of this study is to take another look at the data that has already been collected because when the Department of Natural Resources looks at the data, they just use one metric, the Missouri Stream Condition Index. The proposal will use a series of metrics to calculate the numbers in a multitude of ways.
