Proclamation

Commission

6. Public Comment

CJ Dykhouse said it is noted that Mr. Wyse is present in the gallery today with the intent of

addressing the Commission regarding a matter involving Seth Reynolds. Dykhouse said he wanted to create a very clear record that Mr. Wyse has been informed by verbal communication as well as written, since a meeting at the end of October 2018, that the County Counselor's Office represents the County's officers and directors in all matters pertaining to Seth Reynolds. Mr. Wyse has repeatedly, and most recently with a letter that was addressed directly to the Commission, violated the rules of professional conduct; specifically, Supreme Court rule 4-4.2, regarding communications with people represented by counsel. Dykhouse explained he wanted the record to be very clear that he represents the County Commission in matters involving Seth Reynolds. Mr. Wyse is forcing Dykhouse's hand in clarifying that, for the record, for purposes of later review by appropriate authorities of how he has conducted himself. If Mr. Wyse has other dealings with County Government that are not related to the representation of Seth Reynolds, Dykhouse would not assert the need to go through him for that. However, in matters involving Seth Reynolds, the Commission is represented by the County Counselor and communication with attorneys that represent Seth Reynolds directly with Commission is largely inappropriate.

Commissioner Atwill asked if it was appropriate to say that matters between the County and Seth Reynolds are still in litigation.

Dykhouse said yes. They have been litigated repeatedly. Tom Schneider is the attorney of record in that matter. The County was successful at the trial-court level. That case was appealed the first time to the Western District Court of Appeals, then there was a contempt citation that was successful for the County. That order was also appealed to the Western District and the Western District has not issued its mandate yet, but the decision was favorable to Judge Asel's decision in that matter.

Commissioner Atwill stated Mr. Wyse may make a statement on the record if he so wished.

Steve Wyse said Mr. Dykhouse informed him that if he wanted to address the Commission in

a meeting that it would not be inappropriate. In fact, he believes the rules permit him to address his governing body in any manner that he deems appropriate, including on behalf of another citizen. There is nothing inappropriate about addressing the governing body of Boone County. Wyse submitted a letter to the County last Friday detailing gross errors in the survey the County submitted in the case involving Seth Reynolds. The conduct of the surveyor is a matter of public concern for every citizen of Boone County. It is arguable that the survey submitted by the County Surveyor could be deemed as an apparent fraud for its failure to comply with the statutory commands. Wyse has repeatedly asked for an opportunity to formally address the Commission on this matter and has been denied an opportunity to do so. He has communicated with the County Counselor's Office previously with an offer of settlement and no response was ever received. No indication was ever given that the County has even received that communication. That is inappropriate. The County Counselor has an obligation to at least respond and County Commission has an obligation to take a position on it. The refusal to respond to any other communication leaves this as the only format to which he can be sure that communication actually occurs.
