9. First & Second Reading; Approval of Mini-Grant: University of Central Missouri – Missouri Safety Center, Click It or Ticket Enforcement Campaign

Gary German explained this is something the Sheriff's Department has already been doing for quite some time. In speaking with the Auditor's Office, it was thought the Sheriff's Department could be doing a bit better as far as reporting aspects. Throughout the course of the year these mini grants are given out through different enforcement campaigns such as Click It or Ticket or when extra enforcement is out during Saint Patrick's Day or Cinco De Mayo. Historically, these things haven't been presented to the Commission as they probably should have been, so it is likely these types of mini grants will be brought to the Commission on a more frequent basis. This is a little different in that, whereas sometimes there would need to be an application, approval, and acceptance, the Sheriff's Department has already been verified as be eligible and they will approach the Sheriff's Department and ask them to participate in the event or campaign. There is no cost to the County for this.
