1. Presentation of the 2019 Digital Counties Survey Award

Office of Emergency Management

Enclosed is the 2019 Emergency Management Performance Grant (EMPG) Award. The EMPG funding is a 50/50 cost split between the County and FEMA in an effort to ensure Emergency Management (EM) is effective across the country. Application for this grant was approved on Commission Order 117-2019.

Martin explained the total award is \$231,000, with the match amount being \$115,000 from the County and \$115,000 from FEMA. This will pay for half of the siren maintenance and half of three salaries in the Emergency Management Office.

BOONE COUNTY NAMED TOP TEN BY CENTER FOR DIGITAL GOVERNMENT

July 11, 2019— For the tenth year in a row, Boone County earned recognition for successful outcomes through strategic use of information and communications technology. On Thursday, July 11, the Center for Digital Government (CDG) and the National Association of Counties announced the top ten counties in each of five population categories, including Boone County, which ranked fifth place among counties with a population between 150,000 and 249,999. Boone County has been ranked in the top ten counties of similar population for 14 of the past 15 years.

The 17th Annual Digital Counties Survey, which is open to all U.S. counties, is conducted by the Center for Digital Government in partnership with the National Association of Counties. The self-report survey offers counties an opportunity to share the outcomes they have accomplished through the strategic use of technology. Winners are chosen based on the best technology practices among U.S. counties, including initiatives that streamline delivery of government services, encourage collaboration and shared services, enhance cybersecurity and contribute to disaster response recovery efforts.

"Innovative counties across the U.S. are leveraging technology and data to complete unique projects that better serve citizens, save taxpayer money and protect citizen data," said Teri Takai, executive director, CDG. "The Center for Digital Government congratulates this year's winners for their work to make government work for the citizens and businesses they serve."

"Technology plays an important role in achieving healthy, safe and vibrant counties.
