Health Department

1. First & Second Reading; Abatement of Property located at 2510 E Oakbrook Drive A+B, parcel #12-415-20-02-018.00 01

Kris Vellema explained this is one of the vacant lots on Oakbrook that they mow each year. This is one of the pair that did not get purchased at the last Tax Sale. The mowing contractor is going to be out of town until next week, so this won't be able to get mowed until late next week likely. The bid will probably be a little expensive since this is one that will need to be done by hand.

Brian McCollum said that this property has been a problem for many years. It is currently being offered in a Post Third offering and the Collector's Office is currently accepting

sealed bids for this property. He asked that this abatement be postponed until after the sealed bids are opened on November 5th, and then the County could work with the new owner on it so there would not be any additional costs or surprises to this.

The Commission agreed it would be best to wait on this property as it might cost more to mow it than what the property would sell for.
