The meeting was called to order at 1:31 p.m.

Commissioner Atwill made note of an event honoring the life of Elizabeth Ames Hotchkiss that will be taking place this upcoming Sunday and wanted to read a proclamation in her honor.

Commissioner Atwill read the following proclamation:

Whereas, Elizabeth Ames Hotchkiss was born to Edward O. and Elizabeth Wood Bogert in New York City, New York, on April 1, 1934; and

Whereas, she spent her childhood in New York and, at the age of 7, she began riding horses and rode trails on Eastern Long Island with her father. This began a lifelong journey toward the mastery of the Equestrian sport of Dressage and Eventing; and

Whereas, Liz spent her early years in schools in East Hampton, attended a

boarding school in Maryland and College at Goucher College; and

Whereas, at the age of 21, she became a Certified Riding Instructor and began her career riding and training in the early 1960's; and

Whereas, Liz and her husband, Larry, started Stony Hill Stables in 1965 in Amagansett, New York. While there, Liz and her husband became the proud parents of Catherine and Elizabeth, who grew up with horsemanship as part of their lives. Elizabeth still runs the Stony Hill Stables on Long Island; and

Whereas, after the untimely death of her husband, Liz continued the stable operation until her children were grown. Liz then moved to Boone County, Missouri, in 1989 and bought a horse farm she named Stony Hill Farm, where she continued her career of riding and training horses and riders with her partner, Kent McKinney; and

Whereas, Liz began serious study of the fine art of Dressage and began what became an annual winter trip to Wellington, Florida to train with the most respected Dressage riders and trainers in the world; and

Whereas, Liz committed her life to teaching her students the skills and appreciation of horses and the art of Dressage; and

Whereas, Liz was a founder and president of the Columbia Dressage and Combined Training Association. She participated in the creation of the Missouri Dressage Classic and was a competing member of the United States Dressage Federation and the United States Equestrian Federation; and

Whereas, in Dressage, she successfully competed in FEI Prix St. George and earned her Bronze Medal in 1984 and her Silver Medal in 2006; and

Whereas, at the age of 79, she competed with Oliver, age 21, at a recognized show to be granted membership in USDF's Century Club where the combined age of the horse and rider must equal or exceed 100; and

Whereas, Liz's influence in the local Dressage and Eventing community cannot be overstated. Her dedication to all aspects of equestrian excellence will have a long and lasting influence in the history of Boone County.

Therefore, we do hereby honor Elizabeth Ames Hotchkiss for her dedication to the Dressage and Eventing community of Boone County.

8. First Reading; Acknowledgment of receipt of the Chapter 100 Compliance Report from Kraft-Heinz

CJ Dykhouse explained that, as part of the compliance agreement for the Chapter 100, Kraft-Heinz must maintain or create 300 jobs that pay at or above the County average wage. The report being submitted today indicates a total of 451 jobs at the plant, of which 307 pay at or above the County average wage. Dykhouse introduced Marcus Glover, who was present on behalf of Kraft-Heinz.

Marcus Glover said Kraft-Heinz looks forward to continuing to provide jobs in Columbia. The company has a good amount of community involvement and has an active relationship with the Food Bank of Missouri, where they provide food products as well as packaging items, and employees do volunteer work there. Kraft-Heinz also just finished its 26th year of Partners in Education with Derby Ridge Elementary School where they do programs such as Adopt-a-Family and Junior Achievement Day, as well as participating in the school carnivals and some of the teacher committee activities, etc. Commissioner Atwill said that is great. Good cooperate citizenship is appreciated, and thanked Glover for all that Kraft-Heinz does. Atwill asked if there were any plans for a future expansion that could be revealed.

Glover said not at this time. They would very much like for that to happen, but there is nothing to announce at this time.

Commissioner Parry asked if it was correct that Oscar Mayer hotdogs were only made in Columbia, Missouri.

Glover said that is correct. If it is seen in a grocery store in the United States, Canada, or Mexico, it was made in Columbia, Missouri.

Commissioner Thompson said that is amazing and people don't realize that. It would be great if someone from the media were present for this.

Commissioner Atwill thanked Glover for coming today.
