4. First & Second Reading; Abatement of Property located at 2131 S. Alamos Place, parcel #17-513-21-01-113.00 01

Brian McCollum said this property was subject to be sold at the delinquent tax sale for 2018-2019. His office was not aware of the burnt structure. He requested any invoices for the cleaning of the property be remitted to the Collector's Office so they can be included in the tax sale.

Vellema asked what the time frame on that was.

McCollum said July 15<sup>th</sup> is when the ads go out, so by July 10<sup>th</sup> would be good if possible. The amounts can be amended later if needed but it is not ideal. The sale is on August 24<sup>th</sup>.
