### Purchasing

1. Bid Opening: 23-02JUL20 - El Chaparral Culvert Rehab

Robert Wilson opened a bid from Leavenworth Excavating & Equipment Co., Inc (Lexeco) with a total bid amount of \$236,020.00.

Robert Wilson opened a bid from Insituform Technologies USA with a total bid amount of \$160,834.00.

2. First Reading; Contract Award: 04-30MAR20 – Bond Counsel Services for the Boone County Treasurer – Term & Supply

Liz Palazzolo read the following memo:

Request for Proposal 04-30MAR20 solicited proposals for Bond Counsel Services for the Boone County Treasurer's Office. Two proposals were received and reviewed by a Boone County Evaluation Committee consisting of Tom Darrough, Boone County Treasurer; June Pitchford, Boone County Auditor; and C.J. Dykhouse, Boone County Legal Counsel. The Evaluation Committee first met by teleconference June 5, 2020 to discuss the two proposals and the evaluation methodology. It was decided that a "team" evaluation report and scoring would be done. The Evaluation Committee conducted the subjective evaluation and scoring of the offerors' Experience & Reliability, and the Method of Performance. The Purchasing Department conducted the Cost Evaluation with input from the Evaluation Committee. The Evaluation Report is included as an attachment to this memo.

The award of contract will be made to the "lowest and best" proposal which has received the highest score. A contract for Bond Counsel Services will be awarded to Gilmore & Bell, PC of Kansas City, Missouri.

The contract period will run from July 1, 2020 through June 30, 2025, and there are two (2) one-year renewal options available after this initial period.

This is a Term & Supply contract.

There were no comments or questions from the Commission.

3. First Reading; Emergency Purchase Agreement: 16-30SEPE – Summer Meals for Kids Program with Harrisburg R-VIII School District

Liz Palazzolo read the following memo:

Attached for signature is a contract for a non-bid, emergency services contract.

16-30SEP20E - Summer Meals for Kids Program.

Harrisburg will hold summer school the last two weeks of July and the first week of August. This contract will provide breakfast and lunch to 225 students from date of contract award until summer school begins.

The contract is with Harrisburg R-VIII School District in Harrisburg, Missouri. The total cost of the agreement is \$106,560.00 and payments will be made from department 2161 - CCS Funding Opportunities, account 71100 - Outside Services. The fixed price for congregate meals is \$5.92/meal for 18,000 meals.

There is currently a remaining budget of \$644,187.00.

Commissioner Atwill asked why Harrisburg schools were getting funding but not other schools.

Joanne Nelson explained that since Harrisburg is a smaller school, they do not qualify through DESE.

Commissioner Atwill was concerned about the cost.

Nelson said other schools are also getting funding, but they are receiving it through different providers. All schools had an opportunity to apply for funding. The funding of this program for Harrisburg would ensure that all the schools have funds for the summer meals program. The price is \$5.92 per meal and the program will deliver 18,000 meals. School buses will deliver breakfast and lunch at the same time to rural areas where children do not easily have access to other places to get meals if they can't get them at home.

Commissioner Parry asked Nelson to get the Commission a bit more information before the second reading of this item.

There were no more comments or questions from the Commission.

4. First Reading; Budget Amendment: Appropriate funds provided from the State of Missouri from the CARES Act

June Pitchford explained that since the funds the County received from the State for the CARES Act were not contemplated in the budget process, a budget amendment will need to be done to appropriate those funds. The Commission has identified a need for software that will support accountability and transparency when it comes to the County disbursing any of the funds received from the CARES Act and the balance of the funds will be appropriated into Contingency.

## Sheriff's Department

11. First Reading; Budget Amendment: Establish a budget for two 2019/2020 Missouri Internet Crimes Against Children Task Force grant sub-awards

The first award was for \$15,065.41 and the second award was for another \$4,000. The funds are specifically to be allocated towards equipment technology and training.
