Purchasing

1. First Reading: Contract: 43-14DEC20 - Shop Fluids - Term & Supply

Buyer Robert Wilson read the following memo:

Two (2) bids were received. Road & Bridge recommends award by low bid to Champion Brands, LLC.

This is a term and supply contract and will be paid from department 2042 – Road & Bridge Fleet Maintenance Operations, account 59050 – Engine Fluids.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

2. First Reading: Contract Amendment for Signature: 16-30SEP20E - COVID-19 Response Plan - Mental Health with the University of Missouri - (Emergency Purchase Agreement for the COVID-19 Pandemic)

Purchasing Director Melinda Bobbitt read the following memo:

This amendment adds a renewal, not to exceed amount of \$100,000.00, which will allow the University of Missouri to continue to provide services for another year ending December 31, 2021.

The purpose of this contract is to increase access for immediate, brief support for Boone County children, youth and families through existing mental health providers using telehealth modalities. Cost of service is \$80/hour for up to 1,250 hours.

Contract is with The Curators of the University of Missouri (on behalf of the Missouri Prevention Science Institute) of Columbia, Missouri. Invoices will be paid from department 2161/ Account 71106. \$750,000.00 is budgeted for 2021.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

3. First Reading: Contract Amendment for Signature:19-02MAY19 - Family Access Center for Excellence or FACE

Director of Purchasing Melinda Bobbitt read the following memo:

Contract Amendment #1 to 19-02MAY19 - Family Access Center for Excellence, or FACE, of Boone County, with The Curators of the University of Missouri (on behalf of the Missouri Prevention Science Institute) of Columbia, Missouri.

This amendment transfers the Purchase Agreement for Boone County Schools Mental Health Coalition from The Curators of the University of Missouri (on behalf of the Boone County Schools Mental Health Coalition), Purchase Agreement 34-18JUL19, to The Curators of the University of Missouri (on behalf of the Missouri Prevention Science Institute) FACE of Boone County Agreement for Access to Services 19-02MAY19. The Family Access Center of Excellence (FACE) of Boone County was designed to support families with a child (age 0-19) to expand choices of and promote access to a range of social support services.

Total cost of services for 2021 shall not exceed \$2,796,110.00 and invoices will be paid from department 2162/ account 71106. \$11,500,000.00 is budgeted for 2021.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

4. Second Reading: Contract Agreement: 01-31DEC21C - Telecommunication Service Contract for the Boone County Jail - a COVID-19 project (First Read 01.21.21)

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve the non-bid Contract Agreement: 01-31DEC21C -Telecommunication Service Contract for the Boone County Jail - a COVID-19 project. The dollars spent against this contract are less than our bid required threshold of \$6,000 in a 90-day period. This project is a COVID-19 project that will be paid for with CARES Act funding. The ongoing services will be paid for out of the IT budget and also with CARES Act funding to the extent that they occur within the applicable deadline.

This contract adds internet service in the Boone County Jail in a designated area for use by inmates, attorneys, medical personnel, etc. to communicate. The monthly recurring charges are \$234.95 / month as follows:

Contract is with Socket Telecom, LLC of Columbia, Missouri. Invoices will be paid from department 1172 - IT Hardware/Software-General Fund, account 48002 - Data Communications. \$35,605.00 is budgeted for 2021.

Human Resources

5. First Reading: Human Resources- Request for standing authority to hire above FHR in position 930- Elections Office Specialist II, Part-time Pool

Director of HR Jenna Redel stated this is a request from the County Clerk's office for standing authority to hire above the flexible hiring maximum for position 930. Director Redel stated position 930 is a pool position, which means they are allocated a specific amount of money which they can use toward hours for employees. In this position, she hires Office Specialist II's, which they use for people who come into the position either with prior elections experience or with a specialized skill. The County Clerk's office is asking for standing authority to hire these Office Specialist II's at \$15.00 an hour, which is above FHR for the position but it prevents us from having to adjust the pay range for the position, which would put it out of sync for the rest of the County. There will be no budget impact for this position.

6. First Reading: Hartsburg Sign Shop Cooperative Agreement
