The meeting was called to order at 1:30pm.

Sheriff's Office

1. First Reading: St. Charles City K-9 Basic Training Contract

Major Gary German, from the Boone County Sheriff's Office, stated this is the standard basic police K-9 dual purpose dog. Major German stated his office has done a couple other dogs for St. Charles in the past, so they have requested their office to train one of their handlers and a dog as well. Major German stated St. Charles Police will purchase the dog and the Boone County Sheriff's Office will assist in selecting a dog.

Commissioner Thompson stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

2. First Reading: Budget Amendment Video Court Expansion Project

Major Gary German, from the Boone County Sheriff's Office, stated they are requesting to expand video court. Major German stated years ago, they had a video court unit for which they utilized the jail chapel and then they put in a secondary unit, which served as an attorney/client room. Major German stated, as they were looking at things, the detention staff can get into one of the systems and reset it if there is a problem but the other one is locked with no access. Major German stated, if the system locks up, they have to rely on the Court's IT staff to either remotely turn it on or turn it off or they have to respond out to the jail. Major German stated the other part to this situation is both of those units are about seven years old and throughout the pandemic they pushed more things toward video court and feel that was a pretty good concept and works well. Major German stated it greatly reduces staff manpower when they have to take inmates down and stated if they can push as much as they can through the video court method, it's safer for both the staff and the detainees.

Commissioner Thompson stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Road & Bridge

3. First Reading: The Missouri Department of Conservation CART program participation

Director of Road & Bridge Greg Edington stated this program is to gravel the roads up to the state parks within Boone County. Director Edington stated his department applies the gravel and is then reimbursed for material costs. Director Edington stated this is a request from the Road & Bridge Department to submit their application to participate. Director Edington stated Road & Bridge has been doing this service for several years and it's been very successful.
