Commission

1. First and Second Reading: Proclamation Recognizing September as National Suicide Prevention and Action Month

Commissioner Aldred read the following Proclamation:

Whereas, according to the National Institute of Mental Health, suicide is the twelfth leading cause of death overall in the US, claiming the lives of over 45,900 people in 2020; and

- Whereas,** in the United States in 2020, there were nearly two times as many suicides as there were homicides, with an average of 130 suicides completed daily and an estimated 1.2 million attempts made; and
- Whereas,** suicide is the second leading cause of death among individuals between the ages of 10-14 and 25-34; the third leading cause of death among individuals between the ages of 15-24; and the fourth leading cause of death among individuals between the ages of 35 and 44; and
- Whereas,** Boone County is not exempt from this devastating trend, with 119 suicides having been completed in Boone County between 2016 and 2020, with the male suicide rate being nearly three times higher than the female rate; and
- Whereas,** suicidal thoughts can affect anyone, regardless of age, gender, race, orientation, income level, religion, or background; and each and every suicide directly impacts a minimum of 100 individuals, including family, friends, co-workers, neighbors, and community members; and
- Whereas,** September, as National Suicide Prevention Awareness Month, is a time for all community members to gain an awareness of how they can help decrease the risk of suicide by speaking openly about the importance of mental health and the impacts of suicide; to help remove the surrounding stigmas; and to help provide access to support services for those in need; and
- Whereas,** local campaign Look Around Boone believes mental health is “everybody’s business,” in a literal sense, and therefore encourages the community to work toward reducing mental health stigma and encourages youth and families to address social, emotional, and behavioral concerns; and
- Whereas,** regional organizations, like Suicide Prevention Services and American Foundation for Suicide Prevention Greater Mid-Missouri, and national organizations, like the National Alliance on Mental Illness (NAMI) and the National Suicide Prevention Lifeline, are on the front lines of a war many refuse to acknowledge, as suicide and mental health remain, for many, too uncomfortable to discuss.
- Therefore,** the Boone County Commission does hereby recognize September as National Suicide Prevention Awareness Month, identifies suicide prevention as a priority, and encourages all Boone County citizens to learn how they can help their loved ones and their community at large.

Co-Director of FACE of Boone County Adielle Ehret stated she would like to express her appreciation for the County Commission taking suicide seriously and creating this Proclamation.

Commissioner Atwill moved now on this day, the County Commission of the County of Boone does hereby enter into the record, the Proclamation Recognizing September as National Suicide Prevention and Action Month.

Commissioner Aldred seconded the motion.

Health Department

2. First and Second Reading: Nuisance Abatement - Parcel# 12-901-26-02-011.00 01

Environmental Health Specialist Supervisor Chrystal Smart stated this property has been in violation since the end of July 2022. The owner has a pool in the backyard creating a mosquito harborage that the neighbor has complained about. Ms. Smart stated she has attempted contact with the owner but has not heard anything from them. Ms. Smart stated she was back by the property last Tuesday and the property was still in violation.

Commissioner Aldred moved now on this 29th day of September 2022, the County Commission of Boone County, Missouri met in regular session and entered the following findings of fact, conclusions of law and order for abatement of nuisance:

Findings of Fact and Conclusions of Law

The County Commission finds as fact and concludes as a matter of law the following:

1. The Boone County Code of Health Regulations (the “Code”) are officially noticed and are made a part of the record in this proceeding.
2. The City of Columbia/Boone County Health Department administrative record is made a part of the record in this proceeding and incorporated herein by reference. In addition, any live testimony of the official(s) of the department and other interested persons are made a part of the record in this proceeding.
3. A public nuisance exists described as follows: trash, rubbish, garbage, and public health hazard due to stagnant water in pool.
4. The location of the public nuisance is as follows 4040 N Hwy PP, Columbia, MO, a/k/a parcel# 12-901-26-02-011.00 01., El Rey Heights Lot 15, Section 26, Township 49, Range 12 as shown by deed book 4760 page 0001, Boone County
5. The specific violation of the Code is: trash, rubbish, and garbage in violation of section 6.5 of the Code and public health hazard due to stagnant water in pool in violation of section 6.6 of the Code.
6. The Health Director’s designated Health Official made the above determination of the existence of the public nuisance at the above location. Notice of that determination and the requirement for abatement was given in accordance with section 6.10.1 of the Code on the 30 day of June 2022, to the property owner and lien holder.
7. The above described public nuisance was not abated. As required by section 6.10.2 of the Code, the property owner and lien holder was given notice of the hearing conducted this date

3. A public nuisance exists described as follows: *trash, rubbish, garbage, and broken furniture.

4. The location of the public nuisance is as follows 7631 Zack Rd, Columbia, MO, a/k/a parcel# 12-204-10-01-011., Valley Park SD Lot 1, Section 10, Township 49, Range 12 as shown by deed book 2694 page 0104, Boone County

5. The specific violation of the Code is: trash, rubbish, garbage and broken furniture in violation of section 6.5 of the Code.

6. The Health Director's designated Health Official made the above determination of the existence of the public nuisance at the above location. Notice of that determination and the requirement for abatement was given in accordance with section 6.10.1 of the Code on the 26 day of May 2022, to the property owner.

7. The above described public nuisance was not abated. As required by section 6.10.2 of the Code, the property owner was given notice of the hearing conducted this date before the Boone County Commission for an order to abate the above nuisance at government expense with the cost and expense thereof to be charged against the above described property as a special tax bill and added to the real estate taxes for said property for the current year.

8. No credible evidence has been presented at the hearing to demonstrate that no public nuisance exists or that abatement has been performed or is unnecessary; accordingly, in accordance with section 6.10.2 of the Code and section 67.402, RSMo, the County Commission finds and determines from the credible evidence presented that a public nuisance exists at the above location which requires abatement and that the parties responsible for abating such nuisance have failed to do so as required by the Health Director or Official's original order referred to above.

Order For Abatement Chargeable As a Special Assessment To The Property

Based upon the foregoing, the County Commission hereby orders abatement of the above described public nuisance at public expense and the Health Director is hereby authorized and directed to carry out this order.

It is further ordered and directed that the Health Director submit a bill for the cost and expense of abatement to the County Clerk for attachment to this order and that the County Clerk submit a certified copy of this order and such bill to the County Collector for inclusion as a special assessment on the real property tax bill for the above described property for the current year in accordance with section 67.402, RSMo.

Commissioner Atwill seconded the motion.

Community Services

4. **First Reading: Budget Amendment - Dept 2130 - FY22 MO Foundation for Health**

Director of Community Services Joanne Nelson stated this funding will go towards staff members salaries as well as training and training materials. Director Nelson stated this is part of a three-year grant with this being the first half of the grant they have received.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

13th Judicial Circuit Court

5. First Reading: Budget Amendment – Dept. 1210 - Sound System Upgrade of 2 South Courtroom

Deputy Court Administrator Derek Hux stated this is not a request for new funds. Instead, they are requesting to move funds from one bucket to another bucket so it can be better labeled. Mr. Hux stated the amount is \$20,445.00 which is for upgrading the technology to the south courtroom. Mr. Hux stated these funds are going to come out of the Law Library Fund and they are wanting to move them to the General County budget so they can be tagged as Class 9 fixed assets.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Purchasing

6. First Reading: Computer and Peripheral Surplus Disposal

Senior Buyer Liz Palazzolo read the following memo: The Purchasing Departments requests permission to dispose of the following list of surplus PC'S, peripheral equipment, unworking air conditioners, file cabinets, and other miscellaneous items through MRC Recycling Center. MRC Recycling will pick up our surplus for fifty dollars per load. Tubed monitors and TV's cost extra. There is also an extra charge for items with freon. They are a State of Missouri, DNR Level Four recycling center. No computer items are land-filled. Purchasing will obtain a Certificate of Destruction, and we will let them know that we want everything recycled, not reused so nothing ends up in the landfill.

Prior to Computer surplus coming to Purchasing for disposal, Information Technology has removed the hard drives for destruction by their department. Their procedure for PC disposal is:

Once all the data is copied or recovered for the user, IT removes the hard drive and memory from the PC. The memory is held to be used for upgrading other PCs at the county that can benefit. IT sometimes removes parts that can be used as spare if the model is current enough. (ie Power Supplies, Video Cards, etc.) The hard drive is held for a minimum of 30 days in case a user identifies something is missing. After 30 days IT may reuse the hard drive in other county

PCs if there are failures. If a hard drive goes unused or fails and IT needs to physically dispose of it, they drill a 5/8" hole through the drive and the data platters. Once IT has collection of "drilled" drives, they deliver them to PC recycling vendor, MRC Recycling Center.

MRC Recycling Center certifies that they have picked up the following items and that all items will be recycled, not reused, so nothing ends up in the landfill.
