1. FY 2023 Proposed Budget (Open Public Hearing)

10. Proclamation Recognizing Dan Atwill on his retirement

The following Proclamation was placed into the record:

Whereas, Dan began his career in Boone County as a student at the University of Missouri, earning a Bachelor of Arts degree in 1969 and graduating from the University of Missouri Law School in 1971; and

- Whereas, Dan served in the United States Air Force as a Captain in the JAG Corps from 1972 to 1976, where he served as Chief of Military Justice at Nellis, Air Force Base, Nevada, and later as an attorney at the Headquarters of USAF Communications Command at Richards Gebaur Air Force Base, in Belton, Missouri; and
- Whereas, after four years of service in the Armed Forces, Dan returned to Columbia, Missouri, to practice law with the firm of Knight & Ford, and for 24 years, he was involved in legal disputes, including commercial litigation, automobile incidents, divorce litigation, train accidents, chemical spills, and workers' compensation cases; and
- Whereas, in 2000, Dan co-founded the law firm of Atwill & Montgomery and continued to practice law until his appointment as Presiding Commissioner of Boone County; and
- Whereas, in 2011, Dan was appointed to the role of Presiding Commissioner by Governor Jay Nixon, and he would be elected to the position in 2012 and reelected in 2014 and again in 2018; and
- Whereas, as liaison to the Boone County Public Works Department, Dan helped lead that department in its diligent maintenance of 800 miles of county roads, including the construction of new interchanges, access roads, and roundabouts; and
- Whereas, Dan anticipated the needs of Battle High School and the community and led the effort to widen Rt. Z and replace the Rt. Z I-70 overpass to accommodate the opening of Battle High School; and
- Whereas, Dan helped coordinate the passage of a tax that created a new 911 service that assumed countywide responsibility for call taking and dispatching of fire, police, and ambulance services, eliminated the 911 telephone service tax, and created a new Emergency Management Department in Boone County; and
- Whereas, Dan supported the establishment of the Community Services department which would coordinate and oversee the disbursement of funds from the Children's Services sales tax, a portion of the Boone Hospital Lease Revenue, and other social service funding; and
- Whereas, Dan helped to negotiate a transfer of the Fairgrounds property to the City of Columbia so that it can be managed for the benefit of all Boone County citizens by the City's capable Parks Department; and
- Whereas, Dan was appointed to the Small Modular Reactor project and the State Workforce Development Board and served as Chair of the Mid-Missouri Regional Planning Commission; and
- Whereas, Dan served as liaison for the Office of Emergency Management, Boone County Fire Protection District, Boone Hospital, Columbia Area Transportation Study

- Organization, Columbia Chamber of Commerce, Industrial Development Authority, Local Emergency Planning Commission, and Missouri Innovation Center.
- Whereas, Dan and his wife, Karen Eads Atwill, have been married since 1968 and are the proud parents of Dana Wilhite, D.V.M; Kirsten Craver, J.D.; Daniel E. Atwill, a realtor; and the proud grandparents of seven grandchildren; and
- Whereas, after an esteemed career, retirement will grant Dan time to spend with his grandchildren, maintain his 15 acres of property, and get much-deserved rest; and
- Therefore, we do hereby recognize the contributions of Daniel K. Atwill to this community, congratulate him on his retirement, and thank him for his dedication to the citizens of Boone County.

- Whereas, Nora began her service to the citizens of Boone County in 1996 as a Deputy Recorder, a role she held until 2014; and
- Whereas, in 2014, Nora was elected as Boone County Recorder of Deeds and was then elected for a second term in 2018; and
- Whereas, Nora is an active member in the Recorder's Association of Missouri and The International Association of Government Officials (iGO), an organization for which she served as Director at Large for the Recorder Division in 2016; and

- Whereas, one of her crowning accomplishments as Recorder of Deeds was on June 26, 2015, when she had the honor of issuing the first marriage license to a same sex couple in Boone County; and
- Whereas, during her time as Recorder of Deeds, Nora received recognition from several organizations, including the 2015 Betty Saunders Elected Officials Award from Muleskinners, the 2018 Jonas Viles Award from the Missouri Recorder's Association, and 2021 MAC Service Award from Missouri Association of Counties; and
- Whereas, Nora also served as a member of the Boone County Bicentennial Committee, collaborating with other elected officials and community members to celebrate Boone County Bicentennial Celebration in 2020; and
- Whereas, Nora was a member of the Missouri Honor Choir and is very active in community theater, having performed in many plays and directed others.
- Therefore, we do hereby recognize the contributions of Nora Dietzel to this community, congratulate her on her retirement, and thank her for her dedication to the citizens of Boone County.

- Whereas, June has successfully run for the seat of Boone County Auditor eight times, only the first of those with opposition; and
- Whereas, in 1996, June received the designation of Certified Government Financial Manager from the Association of Government Accountants (AGA); and
- Whereas, June has received national recognition for both budget preparation and report design; and
- Whereas, during her time at Boone County, June has served on the County Employees Retirement Fund (CERF) Board of Directors, which ensures the fund is stable and secure for present and future retirees, establishes investment guidelines, oversees the management of fund assets, and researches options for improving the plan design and benefit structure; and
- Whereas, June is a past president of the Missouri Association of County Auditors and a past board member of the Missouri Association of Counties, in addition to her active service in several professional organizations including Government Finance Officers Association (GFOA) and (AGA); and
- Whereas, June was the inaugural recipient of the Guardian of Good Government Award in 2000, an award presented by Boone County Citizens for Good Government in recognition of her "outstanding dedication to the principles of good government on behalf of the citizens of Boone County, Missouri;" and
- Whereas, June and her husband, Paul, have been married for 41 years and are the proud parents of Abby, Morgan, and Harison, and proud grandparents to Penelope, Hazel, and Callum; and
- Whereas, following an illustrious career, retirement will bestow upon June much-deserved additional time to spend with her beloved family, doing things she enjoys such as landscaping and gardening, at which she is very skilled.

- WHEREAS, at dawn on December 7, 1941, the Imperial Japanese Navy launched a surprise attack on the United States naval base at Pearl Harbor, Hawaii; and
- WHEREAS, this devastating attack cost 2,403 service men and civilians their lives and injured 1,178 more; sank two United States Navy Battleships, the USS Arizona and the USS Utah; and destroyed 188 aircraft; and
- WHEREAS, after the attack, President Franklin D. Roosevelt called on the Congress to declare war, ensuring that "this form of treachery shall never again endanger us" and marking the United States' entrance into World War II; and
- WHEREAS, some 82 members of the Armed Forces from Boone County were killed during World War II; and
- WHEREAS, On August 23, 1994, Congress designated December 7 as National Pearl Harbor Remembrance Day; and
- WHEREAS, December 7, 2022, marks the 81st anniversary of the attack on the Pearl Harbor Naval Base; and
- WHEREAS, it is fitting to observe this day as a time to honor all who served in the United States Armed Forces on December 7, 1941, especially those from Boone County Missouri, and to reflect upon their sacrifices and on the losses endured by military members and civilians alike; and
- THEREFORE, The Boone County Commission does hereby proclaim December 7, 2022, as Pearl Harbor Remembrance Day in Boone County, Missouri.
