10. Commissioner Reports

Commissioner Thompson stated yesterday, courtesy of Trent Watson, who is the lobbyist for the Missouri Association of Counties, and Steve Hobbs, the Executive Director for the Missouri Association of Counties, members of the Policing, Justice and Mental Health Steering Committee met with members of the Governor's staff. Commissioner Thompson stated the issues discussed were mental health, primarily in the justice-involved community, and with respect to the individuals with mental health issues who are clients of the Public Administrators in Missouri. Commissioner Thompson stated the staffers asked what kind of actions were requested that the Governor take, and they have a report that will go from the Executive Committee of the Missouri Association of Counties to the Governor's Office for his consideration. Commissioner Atwill added that he saw the Columbia Housing Authority received an award of \$15 million in tax credits, which is the amount the County was holding them to obtain before effectuating the \$5 million set aside.
