The meeting was called to order at 1:30pm.

Commissioner Atwill requested to present a Proclamation at the beginning of the meeting.

Commissioner Atwill read the following Proclamation:

- Whereas, Dr. Harris arrived in Boone County in 1957 to attend the University of Missouri Medical School, joining one of the first cohorts at the University's newly established four-year program; and
- Whereas, after receiving his M.D. in 1961, he began his pediatric internship and residency at the University of Missouri, completing his residency in 1964; and
- Whereas, following his residency, Dr. Harris opened a private practice in the esteemed "Doctor's Park" on West Broadway, where he would practice for the next nine years.

In 1968, Dr. Harris and a group of 20 other physicians invested in a new building, purchasing several acres of land in the then-undeveloped east side of Columbia; and

- Whereas, in 1973, Boone Clinic opened its doors, and Dr. Harris became a founding member of Boone Clinic Pediatrics; and
- Whereas, Dr. Harris quickly earned acclaim within the medical community, receiving the Distinguished Service Award from the University of Missouri Medical Alumni Association in 1987; and
- Whereas, in 2012, Dr. Harris received the Missouri Child Advocacy Award from the Missouri Chapter of the American Academy of Pediatrics; and
- Whereas, Dr. Harris's passion for the welfare of children was evident even outside of his medical practice. In 1981, he joined the Columbia Board of Education, serving as President from 1984 to 1986, and ending his service on the Board in 1990; and
- Whereas, Dr. Harris served as a Board Member to the Missouri Children's Trust Fund from 2009 to 2015, and received an award for Outstanding Board Service in 2012; and
- Whereas, Dr. Harris had the honor of receiving the Humanitarian Award from the University of Missouri International Center for Psychosocial Trauma in 2018; and
- Whereas, Inside Columbia magazine named Dr. Harris as part of "The Como 100, Recognizing Those Who Have Shaped Columbia," in the Health Care and Medicine category in 2017. In 2018, Dr. Harris received the Readers' Choice Award for Best Pediatrician from the Columbia Daily Tribune; and
- Therefore, we do hereby recognize the incredible contributions of Dr. Robert J. Harris to this community over his 55-year career and thank him for his steadfast and selfless devotion to pediatric care in Boone County.

Purchasing

1. First Reading: Computer and Peripheral Surplus Disposal

Director of Purchasing Melinda Bobbitt read the following memo:

The Purchasing Department requests permission to dispose of the following list of surplus PCs, peripheral equipment, non-working air conditioners, file cabinets, and other miscellaneous items through MRC Recycling Center. MRC Recycling will pick up surplus items for \$50.00 per load. Tubed monitors and TVs cost extra. There is also an extra charge for items with freon. This is a State of Missouri, DNR Level Four recycling center. No computer items are landfilled. Purchasing will obtain a Certificate of Destruction, and we will let MRC Recycling know that we want everything recycled, not reused, so nothing ends up in the landfill.

Prior to computer surplus coming to Purchasing for disposal, Information Technology has removed the hard drives for destruction by their department. Their procedure for PC disposal is as follows:

Once all the data is copied or recovered for the user, IT removes the hard drive and memory from the PC. The memory is held to be used for upgrading other PCs in the county. IT sometimes removes parts that can be used as spare parts if the model is current enough (e.g., Power Supplies, Video Cards). The hard drive is held for a minimum of 30 days in case a user identifies something is missing. After 30 days, IT may reuse the hard drive in other county PCs if there are hard drive failures. If a hard drive goes unused or fails and IT needs to physically dispose of it, they drill a 5/8-inch hole through the drive and the data platters. Once IT has collection of "drilled" drives, they deliver them to the county's PC recycling vendor, MRC Recycling Center.

MRC Recycling Center certifies that they have picked up the following items and that all items will be recycled, not reused, so nothing ends up in the landfill.

Human Resources

2. First and Second Reading: Request to Hire Above Flexible Hiring Maximum for Position 931, Accountant II

Interim Director of Human Resources Angela Wehmeyer stated this request comes from the Auditor's Office to bring in a candidate above the Flexible Hiring Range (FHR). Interim Director Wehmeyer stated this candidate has over 27 years of accounting experience, and this does not have a big budgetary impact, as they are asking for \$5,500.00 annually over FHR. Interim Director Wehmeyer stated the amount over FHR is saved by the current vacancies in the office. Interim Director Wehmeyer stated the annual amount requested for this candidate is \$62,500.00, and \$2,500.00 of that would be given after the successful completion of a probationary period.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby approve the request to hire above the Flexible Hiring Range for Position Number 931, Accountant II, and does hereby authorize an initial appropriation equivalent to \$60,000.00 annually for the salary of said position and an additional \$2,500.00 annually following the successful completion of a probationary period.

Commissioner Atwill stated almost everyone in public office or involved in public business has talked with Dave at some point and been advised of things and it was important that they get that advice. Commissioner Atwill stated Mr. Shorr will be missed tremendously and he wishes his family the best.

Boone County Counselor CJ Dykhouse stated he has appreciated working for Commissioner Atwill over the last decade. Counselor Dykhouse stated he has learned a lot from Commissioner Atwill, and he feels like he is leaving the County better than he found it. Counselor Dykhouse stated, as a measure of one's presence, he feels that is a pretty good one. Counselor Dykhouse ended by stating it has been a pleasure to serve the people of Boone County with Commissioner Atwill.
