8. Commissioner Reports

Commissioner Thompson stated she and Commissioner Aldred were in Washington, D.C., from February 10 through the evening of February 14 for the NACo Legislative Conference. Commissioner Thompson stated fascinating information was exchanged, and she was very pleased to be able to participate in a panel discussion with former NACo President Mary Ann Borgeson and NACo's first Vice President Mary Jo McGuire about mental health training opportunities that are happening across the country.

Commissioner Thompson stated she also had the great pleasure of chatting with Associate Attorney General Vanita Gupta about the work that the Department of Justice is doing to assist counties and other jurisdictions in addressing issues with mental health and substance abuse disorders.

Commissioner Aldred stated, while he was at the NACo Legislative Conference, he looked at technology and telecommunication funding. He further stated that there are millions of dollars available from the Federal Government for broadband services for both state and local organizations. Commissioner Aldred stated there was good focus on cyber security and the modernization of 911 services.

Commissioner Aldred stated he also serves on the Veterans and Military Services Committee, which went over the PACT Act, which provides benefits to veterans. Commissioner Aldred stated they talked a lot about county Veterans Service Officers, who are individuals at the local level who work to address issues that individuals might have at the VA.

Commissioner Aldred stated that there was discussion regarding food insecurity for current members of the military, which occurs at a surprisingly high rate. Commissioner Aldred stated the current wording in legislation is such that the basic housing allowance the military disburses counts against basic SNAP benefits. They are trying to implement a change for that.

Commissioner Kendrick stated that the Planning & Zoning hearing set for February 28 will be a first reading of Planning & Zoning issues. A second reading of non-administrative items will be held on Tuesday, March 7, 2023.

Commissioner Aldred stated he will be in Hartsburg this evening for an ARPA listening session to both explain the process and to hear from the citizens as to what they might want the money to put towards.
