The meeting was called to order at 9:30am and roll call was taken.

#### **Health Department**

#### 1. First Reading: City of Columbia Public Health Services Cooperative Agreement

Boone County Health Department Assistant Director Rebecca Roesslet stated this agreement is between the City of Columbia and the County of Boone for the provision of public health services. Ms. Roesslet stated this agreement includes public health administration; clinic and nursing; environmental health; social services; the WIC and nutrition program; and utility and medication assistance. Ms. Roesslet stated this is an annual agreement where they bill the County of Boone in quarterly increments and then have a reconciliation at the end of the County's budgetary cycle.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

## 2. First Reading: City of Columbia Animal Control Services Cooperative Agreement

Boone County Health Department Assistant Director Rebecca Roesslet stated this agreement is between the City of Columbia and the County of Boone for animal control services. Ms. Roesslet stated this agreement provides for 2.33 full-time equivalencies of animal control officers.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Director Martin stated the original budget in 2022 was \$300,000.00 and they are requesting to move the amount of \$156,881.00 to continue the work at the site this year.
