The meeting was called to order at 1:30pm and roll call was taken.

Human Resources

1. First and Second Reading: Job Classification Committee Recommendation - Court Request

Director of Human Resources Angela Wehmeyer stated this request comes from the Court Administrator for the 13th Judicial Circuit. Director Wehmeyer stated Ms. Garrett came to the

Job Classification Committee with an urgent request to create a new position for a security officer. Director Wehmeyer stated the current Deputy Court Marshal, Deputy Court Marshal II, Deputy Court Marshal Sergeant, and Deputy Court Marshal positions will be moved to a different location on the pay range. Director Wehmeyer stated they will be tying the Deputy Court Marshal positions to the Detention Officers at the same pay range and ultimately, because of vacancies and savings in the budget, there is no budget amendment needed for this change.

2. First Reading: Budget Amendment Dept 1243 – JJPA Grant

13th Judicial Circuit Court Deputy Administrator Derek Hux stated Court Administrator Cindy Garrett presented on this item at the last Commission meeting but didn't have the correct dollar amount for the Budget Amendment. Mr. Hux stated the correct amount is \$4,679.00.

3. First Reading: Approving Participation Agreements in National Opioid Settlements for Teva, Allergan, CVS, Walgreens, and Walmart

Counselor Dykhouse stated the County Commission hired outside counsel to pursue class action litigation in response to the national opioid epidemic. Counselor Dykhouse stated one round of national settlements has already been processed and approved, and this is the next round of national settlements. Two bids were received; the County is awarding the contract to Christensen Construction Company of Kingdom City, Missouri.

The bids have been reviewed by Micah Taylor, Professional Civil Engineer in the Resource Management Department, and Jeff McCann, Chief Engineer in the Resource Management Department. The bid from Christensen Construction Company is the "lowest and best" bid.

Payment will reference Department/Object codes 2041 – Road & Bridge Resource Management Road Infrastructure Rehabilitation/Preservation/71202 – Contractor Costs: \$2,334,930.65, plus a 10% Contingency amount of \$233,493.07, for a grand total allocation of \$2,568,423.72.
