The meeting was called to order at 9:30am and roll call was taken.

### **Boone County Commission**

## 1. First and Second Reading: Women in Construction Week Proclamation

Commissioner Thompson stated she would like to thank everyone who came today and thanked them for breaking ceilings in their work. Commissioner Thompson stated they do all kinds of work that may not have traditionally been thought of as work for women and, especially this month of the year, she thinks of her mom who, in another field, was a pioneer. Commissioner Thompson stated she celebrates all of the women in construction present today as she celebrates her mom's life.

Commissioner Thompson read the following Proclamation:

- Whereas, the construction community is a driving force in fostering community development through renovation and beautification projects; promotion of skilled trades careers; and a positive vision of the future; and
- Whereas, women comprise 47% of the US workforce, yet account for only 10.9% of the construction industry workforce; and
- Whereas, the construction industry leads all industries in pay equity by having the lowest gender pay gap and exhibiting definitive movement toward the elimination of that pay gap; and
- Whereas, the National Association of Women in Construction (NAWIC), chartered in 1955, is a national association with international affiliates dedicated to the advancement of women in the construction industry, with its core purpose to strengthen and amplify the success of women in the construction industry; and
- Whereas, the Central Missouri Chapter #341, chartered in 1991, provides mentoring, education, and community service opportunities for women employed in the construction industry; and
- Whereas, the Central Missouri Chapter #341 has reached more than 1,800 local elementaryage children through educational programs highlighting careers in construction through hands-on learning experiences and has given more than \$30,000 in local scholarships to students enrolled in construction career programs at State Technical College in Linn, MO; and
- Whereas, in September 1998, following in the strong and innovative footsteps of its founders, NAWIC members announced the inception of Women in Construction Week, a celebration that would later be moved to March to coincide with Women's History Month; and
- Whereas, Women in Construction Week is a call to action for the construction industry to give women in construction the recognition they deserve, the resources they need to thrive, and the support they need to succeed; and
- Whereas, Women in Construction Week 2023's theme is Many Paths, One Mission, a theme which celebrates the different journeys women have taken toward the same goal: strengthening and amplifying the success of women in the construction industry.
- Therefore, the Boone County Commission does hereby proclaim March 5, 2023, through March 11, 2023, Women in Construction Week throughout Boone County and expresses appreciation for the efforts of women in construction within Boone County and across the state of Missouri.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby enter into the record, a Proclamation in recognition of Women in Construction week.

# 2. First Reading: K-9 Basic Training Agreement with the Howard County Sheriff's Office

Captain Brian Leer stated this agreement is for an 8-week, 40 session training that will be provided to the Howard County Sheriff's Office K-9 handler and K-9. Captain Leer stated the amount of this contract is \$4,000.00.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

# 3. First and Second Reading: 2023 Canine Replacement Grant Program Application

Captain Brian Leer stated this was a short notice, short turn-around grant application program of which they were notified the first part of March, with the application deadline today. Captain Leer stated this is funding that the State has re-appropriated to pay for replacement K-9s, to replace the K-9s previously trained in marijuana detection. Captain Leer stated his office wants to apply for funding to replace one of their K-9s. Captain Leer stated they have a K-9 that has been pulled from the road due to the K-9 handler leaving. Captain Leer stated they have reassigned the K-9 to an investigator, and it has limited use at this time. Captain Leer stated the replacement of a K-9 is approximately \$9,261.00 and the equipment they would need to replace to go with this new K-9. Captain Leer stated the deadline to submit for reimbursement is June 10, 2023.

Deputy Director Kelley stated they are also looking for meters and reading devices for the hazmat response teams. Deputy Director Kelley stated this grant is a 100 percent match up to \$100,000.00.
