Boone County Sheriff's Office

1. First Reading: FY2022 JAG Subrecipient Monitoring Agreement

Captain Brian Leer stated this Agreement is required between the City of Columbia and Boone County. It allows the County to ensure they will be able to monitor the activities of the Columbia Police Department as it relates to the use of these funds. Captain Leer stated this is a follow up to the Agreement that was signed previously, where the County was awarded \$36,295.00, of which \$21,777.00 goes to the Columbia Police Department.

2. First Reading: Award of Contract C000618 from RFP 02-30JAN23 for Law Enforcement Uniform Clothing and Boots – Term & Supply to Galls, LLC for the Boone County Sheriff's Office

Senior Buyer Liz Palazzolo read the following memo: Request for Proposal 02-30JAN23 solicited competitive proposals for Law Enforcement Uniform Clothing & Boots for the Boone County Sheriff's Office. Two proposals were received:

- 1) Gall's LLC of Lexington, Kentucky
- 2) Jonah's Enterprises Inc. of Brooklyn, New York

A County Evaluation Committee has evaluated the proposals. Evaluation Committee members are Captain Brian Leer, Leasa Quick (Budget Administrator for the Boone County Sheriff's Office), Captain Jenny Atwell (Assistant Jail Administrator), and Jennifer Basham (Administrative Coordinator for the Boone County Sheriff's Office). The Evaluation Committee conducted the subjective evaluation and the Purchasing Department chaired evaluation meetings and the cost evaluation. One round of negotiations was conducted involving both offerors; both offerors submitted a Best and Final Offer that was also considered in the final evaluation. Evaluation criteria included two subjective areas: Experience/Reliability/Contractor Support, worth a maximum of 20 points, and the Proposed Method of Performance, worth a maximum 30 points.

Cost was evaluated using unit pricing multiplied by the estimated annual purchase quantity using pricing for the initial contract period and all three renewal options. The Cost Evaluation Totals are included and attached to this memo.

The Evaluation Committee conducted subjective evaluation scoring without knowledge of cost point scores. Cost point scores have been added to final subjective scores and the outcome is as follows:

An Evaluation Narrative follows this memo that explains the reasoning for the award of subjective scores.

The Evaluation Committee finds the proposal from Galls, LLC of Lexington, Kentucky to be the "lowest and best" proposal and the choice for contract award. An award to Galls LLC for

Law Enforcement Uniform Clothing and Boots for the Boone County Sheriff's office is presented to the Commission for approval.

The initial contract period will run April 01, 2023 through March 31, 2024; the County will have three (3) one-year renewal options available to renew the contract subsequent to this initial period.
