## 1. Proclamation Recognizing Church Women United Missouri State Assembly

Commissioner Thompson read the following Proclamation:

Whereas, in December 1941, as bombs were dropped and the world was at war, women of faith from three interdenominational women's groups representing 70 denominations convened in Atlantic City, New Jersey, and founded the United Council of Church Women (UCCW), which would later be known as Church Women United; and

Whereas, the United Council of Church Women was founded as a racially, culturally, and theologically inclusive Christian women's movement to celebrate both unity and diversity and to work for peace in the world; and

- Whereas, word of this movement spread quickly, leading First Lady Eleanor Roosevelt to involve the UCCW in a conference at the White House on "how women may share in post-war policy making"; and
- Whereas, since 1941, women of the Church Women United movement have stayed true to their vision of Christian unity and prayerful action; and
- Whereas, each year, at State Assemblies across the nation, the women of Church Women United gather to pray together at the same time, celebrating unity in their vision despite the distance between them; and
- Whereas, on Monday, April 17, 2023, the Missouri State Assembly, chaired by State President Anita Pickens, will be held here in Columbia at Community United Methodist Church; and
- Whereas, the theme for the Missouri State Assembly is "Living a Legacy of Love: Doing God's Work"; and
- Whereas, as coordinator of the Missouri State Assembly, Regional Chairperson Edith Prince shared this opportunity by inviting Church Women United's national leadership as well as representatives from other organizations.
- Therefore, in testimony whereof, the Boone County Commission does hereby recognize Church Women United and honors the women who have made significant contributions to our state and our nation in the pursuit of prayerful action.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby enter into the record, a Proclamation recognizing Church Women United and honoring the women who have made significant contributions to our state and our nation in the pursuit of prayerful action.

Const. Art. 14, Sec. 2. Said additional sales tax has no expiration date.

# 8. First Reading: Surplus Disposal

Senior Buyer Liz Palazzolo read the following memo:

The Purchasing Departments requests permission to dispose of the following list of surplus PCs, peripheral equipment, unworking air conditioners, file cabinets, and other miscellaneous items through MRC Recycling Center. MRC Recycling will pick up our surplus for \$50.00 per load. Tubed monitors and TV's cost extra. There is also an extra charge for items with freon. They are a State of Missouri, DNR Level Four recycling center. No computer items are land-filled. Purchasing will obtain a Certificate of Destruction, and we will let them know that we want everything recycled, not reused so nothing ends up in the landfill.

Prior to Computer surplus coming to Purchasing for disposal, Information Technology has removed the hard drives for destruction by their department. Their procedure for PC disposal is:

Once all the data is copied or recovered for the user, IT removes the hard drive and memory from the PC. The memory is held to be used for upgrading other PCs in the county that can benefit. IT sometimes removes parts that can be used as spare if the model is current enough. (ie Power Supplies, Video Cards, etc.) The hard drive is held for a minimum of 30 days in case a user identifies something is missing. After 30 days IT may reuse the hard drive in other county PCs if there are failures. If a hard drive goes unused or fails and IT needs to physically dispose of it, they drill a 5/8" hole through the drive and the data platters. Once IT has collection of "drilled" drives, they deliver them to PC recycling vendor, MRC Recycling Center.

MRC Recycling Center certifies that they have picked up the following items and that all items will be recycled, not reused, so nothing ends up in the landfill.

One claim has been received from the United States Department of Agriculture (USDA), formerly known as the USA Farmers Homes Association. The Claimant, USDA, is the holder of the Deed of Trust on the subject property recorded at Book 709, Page 270 Boone County Records, with a total amount outstanding of \$92,215.80 as of November 2022. The documentation which supports this claim is made a part of this record. The application of the Claimant to the County Treasurer for the surplus funds is timely.

The County Treasurer, based upon the documents presented to her office and made a part of this record, is satisfied that **United States Department of Agriculture (USDA)** is entitled as claimant to the total surplus of **\$21,372.57**.

NOW, THEREFORE, upon the recommendation of the County Treasurer and the evidence made a part of this record, the County Commission hereby approves the claim of claimant USDA and directs the payment **\$21,372.57** per the USDA's surplus application to USDA, 601 Business Loop 70 West, Parkade Center Suite 235, Columbia, Missouri 65203.
