The meeting was called to order at 9:30 a.m. and roll call was taken.

Human Resources

1. First and Second Reading: Request to Hire Above Flexible Hiring Range for Position 891 – Assistant County Counselor

Boone County Director of Human Resources Angela Wehmeyer stated market data from the City, University of Missouri, and the comparable area employers support this request. Director Wehmeyer stated this request will not impact the budget, and there will be no impact to current employees in the office.

Boone County Counselor CJ Dykhouse stated this candidate has almost 20 years of experience, 17 years as counsel in the nonpartisan House Research Office of the General Assembly, holds both a Bachelor's and Master's Degree in Philosophy and plans to pursue his doctorate in philosophy. Counselor Dykhouse stated this candidate is academic and feels he will be a good

fit for Boone County. Counselor Dykhouse stated this salary comes in at the low end competitively.

Senior Buyer Liz Palazzolo read the following memo: Amendment #3 to contract C000012, from RFP #02-25MAY16 for Detainee Commissary Goods and Services – Term & Supply- for the Boone County Sheriff's Office that was awarded August 17, 2017, (Commission Order 363-2017) changes the inmate debit card processing company from Numi Financial back to the original card processor, Rapid Financial Solutions.

All other terms and conditions, including the commission amount of the original agreement as previously amended, remain unchanged.

This is a Revenue-Generating contract. Coding associated with revenues produced from the contract reference 1255, General Fund Detention Operations/3550 – Commissions.

Senior Buyer Liz Palazzolo read the following memo: Purchasing requests approval for awarding contract C000587, which is co-operative contract CC221938006 for Mailing Equipment, Supplies & Maintenance set up by the State of Missouri using the NASPO Valuepoint contract, with Pitney Bowes of Stamford, Conn. The contract is primarily for maintenance of existing Pitney Bowes mail equipment which is overseen by the Boone County IT Department. Maintenance of Pitney Bowes equipment must be performed by Pitney Bowes manufacturer-certified technicians. The contract includes provisions for the acquisition of new mail room equipment. In this case, the award includes the purchase of a new Letter Opener for the Boone County Collector's Office.

The original contract period will commence April 11, 2023, and extend through May 14, 2024. There are three (3) one-year renewal options available to renew the contract on a year-to-year basis after the original contract period.
