The meeting was called to order at 9:30am and roll call was taken.

Sheriff's Office

1. First Reading: Callaway County K-9 Basic Training Services Cooperative Agreement – May 2023

Captain Brian Leer stated if this training is approved, the Callaway County Sheriff's Office will pay the Boone County Sheriff's Office to provide the training, which will begin in May. Captain Leer stated this will be an 8-week, 40-session training for \$4,000.00.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

2. First Reading: Callaway County K-9 Basic Training Services Cooperative Agreement – October 2023

Captain Brian Leer stated this is the same scenario as the last item, with the training beginning in October.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

3. First Reading: Linn County K-9 Basic Training Services Cooperative Agreement

Captain Brian Leer stated the Linn County Sheriff's Office is replacing a K-9 with the grant opportunity they received and would like to attend the May training. The amount of the contract is \$4,000.00.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Resource Management

4. First and Second Reading: Adoption of Findings of Fact and Conclusions of Law and Issuance of Conditional Use Permits to On Point Construction on Lot 35 and on Lot 36 of Scottsdale Subdivision, Recorded in Plat Book 10, Page 200 of Boone County Records.

Director of Resource Management Bill Florea stated a public hearing was held on this item at the March 28, 2023, meeting and the Commission voted to approve the permits on April 6, 2023. Director Florea stated today is the final step in the process of issuing a conditional use permit, when the Commission accepts the findings of fact and conclusions of law that are necessary to support issuing the permit, and then issues the permit itself.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby adopt the Findings of Fact and Conclusions of Law and issues Conditional Use Permits for On Point Construction, Inc. to allow construction of a duplex in the Single Family Residential (R-S) District on Lot 35 of Scottsdale Subdivision located at 2591 S. Casa Circle and to allow construction of a duplex on Lot 36 of Scottsdale Subdivision located at 4312 W. Mesa Drive.

Commissioner Thompson seconded the motion. The motion carried 3 to 0. **Order #221-2023**

5. First Reading: Utility Agreement between Boone County and Boone Electric Cooperative for the Ben Williams Road Bridge Replacement Project BRO-R010(20)

Chief Engineer Jeff McCann stated this is a utility relocation that is necessary to reconstruct the Ben Williams Road Bridge. Chief Engineer McCann stated at issue is an electric line owned by Boone Electric. A pole near the bridge and two sections of overhead line need to be taken out temporarily while the bridge is being constructed. Chief Engineer McCann stated, once the bridge is done, Boone Electric will reinstall those items. Chief Engineer McCann stated the cost for this is \$4,546.00.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

6. First Reading: Cooperative Contract Award: C000632 (State of MO cooperative contract CT202797053, based on NASPO contract 140599) – Copier for the Juvenile Justice Center with SUMNERONE, INC. for \$5,594.33

Director of Purchasing Melinda Bobbitt read the following memo:

The Boone County Juvenile Justice Center requests permission to utilize the State of Missouri cooperative contract CT202797053 (based on NASPO contract 140599) to purchase a Kyocera TASKalfa 4004i copier with maintenance from SUMNERONE, INC. The county contract number is C000632.

The cost of the copier is \$5,594.33 and will be paid from Department 1242 - GF Juvenile Detention, account 92000 - Replacement Office Equipment (\$7,000 budgeted). The cost of maintenance is \$0.0068 per black and white impression.

Purchasing is seeking permission to dispose of their existing copier by trade for a \$0.00 value. The existing copier is Kyocera TASKalfa-4500i copier, serial # NLS3200534, Asset tag 18431. SUMNERONE, INC. will haul off and recycle the surplus copier at the time they install the new copier. The hard drive will be removed and left with our Information Technology department.
