The meeting was called to order at 1:30pm and roll call was taken.

#### **Employee Recognition Committee:**

The budgeted cost of the contract is \$2,021,981.00.

There will be a 5% contingency on the chip seal portion of the contract, totaling \$101,676.54, making the Purchase Order total \$2,135,207.38.

\$1,309,941.87 will be paid from department 2041 - R&B RM Road Infrastructure Rehab and Preservation, account 71202 - Contractor Costs. There is a 5% contingency of \$65,497.09.

\$723,588.97 will be paid from department 2040 - R&B road maintenance - Outsourced services, account 71100- Outsourced Services. There is a 5% contingency of \$36,179.45. The Purchase Order total is \$2,135,207.38.

### 14. Proclamation Recognizing May 2023 as Mental Health Awareness Month

Commissioner Aldred read the following Proclamation:

Whereas, mental health is an important part of every person's overall health, encompassing a person's emotional, psychological, and social well-being; and

Whereas, a person's mental health influences their thoughts, feelings, and actions; impacts how they handle stress, relate to others, and make choices; and affects their overall ability to function, grow, and thrive; and

Whereas, many factors contribute to a person's mental health, including where one lives, lifestyle choices, life experiences, family history, biological factors, education level, and economic stability; and

Whereas, at some point in their lives, roughly half of all Americans will be diagnosed with a mental illness or disorder; and

Whereas, the long-standing fear and stigma surrounding mental health and mental illness strongly impact if, how, and when a person seeks treatment, leading to fewer than half of those diagnosed receiving treatment for mental illnesses; and

Whereas, physical health and mental health are inexorably intertwined, with untreated mental health conditions increasing the risk for long-term physical health issues such as heart disease, stroke, and diabetes; and

Whereas, growing awareness of and support for mental health in our community helps to challenge the stigma surrounding mental illness, resulting in a community more educated in this vital aspect of each person's health, which can lead to higher overall productivity, better educational outcomes, stronger economies, and improved quality of life; and

Whereas, like physical health, a proactive approach to maintaining mental wellness and a willingness to seek help when struggling with mental health issues will result in better long-term outcomes both for individuals and for the community as a whole; and Whereas, since first being designated as Mental Health Month in 1949, May has been used as a time to raise awareness and education about mental illnesses and the realities of living with these conditions; promote strategies for attaining mental health and wellness; draw attention to suicide, which may be precipitated by some mental illnesses; and reduce the negative attitudes and misconceptions that surround mental illnesses; and

Whereas, Boone County is dedicated to advocating for mental health and those living with mental illness by actively participating in initiatives focusing on justice-involved individuals living with mental illness; supporting local efforts devoted to childhood mental health; and collaborating with other counties to raise awareness of and develop systems to address suicide risk, especially in rural communities.

Therefore, the Boone County Commission does hereby recognize May 2023 as Mental Health Awareness Month and encourages everyone to celebrate the 2023 theme of More Than Enough by remembering the inherent value each person holds—no matter the diagnosis, appearance, socioeconomic status, background, or ability.
