**1. First Reading: Nuisance Abatement –Parcel #12-417-19-01-039.00 01**

Environmental Health Supervisor Chrystal Smart stated this property has been called in a few times over the last several years. Ms. Smart stated the other abatements were for the front yard and this one is for the back yard. Ms. Smart stated the letter she sent to the property owner was returned unsigned. She put an ad in the paper but has not heard back from the property owner.

Property owner Darrell Derritt stated he lives next door to this property. Mr. Derritt stated there is an abundance of cars filled to the top with stuff, trailers filled with stuff, and barrels of water. Mr. Derritt stated his daughter was walking her dog last week and saw a 9-foot snake coming from the property. Mr. Derritt stated the owner brings several trailers of things onto the property almost every evening and the property doesn't have running water due to a backhoe accident the last time

the property was being abated. Mr. Derritt stated the last time the property went through abatement and was cleaned up, the next day there were trailers bringing more stuff onto the property.
